Further to our earlier conversations or correspondence with respect to this matter, please find enclosed our amended Proof of Claim being issued on behalf of 32 employees that have registered claims with the Ministry of Labour.

Our understanding is that there will be insufficient funds available for a distribution to the employees. A purpose of our registering this document with you at the behest of the employees is to fulfil the requirement of Section 81(1)(a) of the *Employment Standards Act, 2000* which reads as follows:

81(1)(a) The directors of an employer are jointly & severally liable for the wages as provided in this Part if,

(a) the employer is insolvent, the employee has caused a claim for unpaid wages to be filed with the receiver appointed by a court with respect to the employer or with the employer's trustee in bankruptcy and the claim has not been paid.

Should our understanding be incorrect with respect to the availability of dividends for the employees, it would be appreciated if you would advise us.




