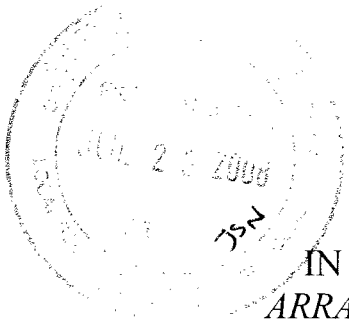

RECITALS


