BANKRUPTCY APPLICATION

JAMES WIERSMA, of the Town of Fisherville, in the Province of Ontario, the Applicant Creditor herein, hereby applies to the Court that Arlan Galbraith be adjudged bankrupt, and that a Bankruptcy Order be made in respect of the property of the said Arlan Galbraith, and says:

1. That the said Arlan Galbraith has at some time during the six months next preceding the filing of this Bankruptcy Application carried on business at the City of Waterloo, in the Province of Ontario, within the jurisdiction of this Court.
2. That the said Arlan Galbraith is justly and truly indebted to James Wiersma in the sum of approximately \$22,746.23 for monies had and received.
3. That James Wiersma holds no security for payment of the said sum.

4. That Arlan Galbraith, within the six months next preceding the date of the filing of this Bankruptcy Application, has committed the following act of bankruptcy, namely:

(a) he has ceased to meet his liabilities generally as they become due in that he has failed to pay his obligations to the Applicant Creditor and to some of his other creditors.

5. That BDO Dunwoody Limited of the City of Kitchener, in the Province of Ontario is a company qualified to act as Trustee of the property of the said debtor and has agreed to act as such and is acceptable to the undersigned creditor:
