Introduction

- On March 8, 2019, the Court of Queen's Bench of Alberta (the "Court") granted an Order (the "Order") appointing BDO Canada Limited as an Interim Receiver in respect of Westpoint Capital Corporation ("WCC"), Westpoint Capital Management Corporation ("WCMC"), Westpoint Capital Services Corporation ("WCSC"), Westpoint Syndicated Mortgage Corporation ("WSMC"), Canadian Property Direct Corporation ("CPDC"), Westpoint Master Limited Partnership ("WMLP"), River's Crossing Ltd. ("RCL"), 1897869 Alberta, Ltd. ("869"), 1780384 Alberta Ltd. ("178") and 1897837 Alberta Ltd. ("837").
- 2. On April 10, 2019, the Court granted an Order (the "Receivership Order") appointing BDO Canada Limited as Receiver ("BDO" or the "Receiver") of the companies referred to in the previous paragraph. On May 30, 2019, the Court granted a further Order, amending the Receivership Order to add The Village at Paldi Ent. Ltd. ("Paldi") as a party in receivership (the companies in receivership are collectively referred to as the "Companies").
- 3. The purpose of this report (the "**Ninth Report**") is to provide this Honourable Court with:
 - A summary of the Receiver's activities since its last report;
 - b) A Statement of Receipts and Disbursements for the period March 8, 2019, to February 7, 2024;
 - c) A summary of professional fees for WCC et al; and,
 - d) Information to support the Receiver's application for discharge.

- 4. The Receiver is seeking a Court Order:
 - a) Approving the Receiver's activities in these proceedings;
 - b) Approving the Statements of Receipts and Disbursements set out herein;
 - c) Approving the passing of accounts for fees and disbursements of the Receiver and its legal counsels for WCC et al.; and,
 - d) Discharging the Receiver.

Limitation of Report

- 5. The information contained in the Receiver's Ninth Report has been obtained from the records of the Company, publicly available information, including an Affidavit sworn by Munir Virani on February 25, 2019, which was filed in these proceedings on February 26, 2019, (the "Munir Affidavit"), and/or based upon discussions with and representations made by the Company's management and other professional advisors retained in this matter. The information relied upon by the Receiver was not audited nor otherwise verified by the Receiver as to its accuracy or completeness, nor has any financial information referenced necessarily been prepared in accordance with generally accepted accounting principles, and the reader is cautioned that this report may not disclose all significant matters about the Company. Accordingly, we do not express an opinion or any other form of assurance on the information presented herein. The Receiver may refine or alter its observations as further information is obtained or is brought to its attention after the date of this Ninth Report.
- 6. The Receiver assumes no responsibility or liability for any loss or damage occasioned by any party because of circulation, publication, reproduction, or use of the Ninth Report. Any use that any party makes of this Ninth Report or reliance on or decisions to be made based on it is the responsibility of such party.

7. A copy of the Receiver's Ninth Report and other relevant documents in the interim receivership proceedings are available on the Receiver's website https://www.bdo.ca/en-ca/extranets/wccetal/.

Background

- 8. Included as part of the Interim Receiver's First Report was important background information to this Ninth Report. The background information is repeated below.
- 9. Westpoint Investment Trust ("WIT" or the "Trust") was established by way of a Declaration of Trust dated June 1, 2015. The Declaration of Trust was amended and restated by an agreement on September 3, 2015, made effective June 30, 2015. The Trust is a mutual fund trust to invest in mortgage and real estate assets.
- 10. Before WIT was established, the assets of the Trust were part of two (2) Mortgage Investment Corporations (the "MICs"). The MICs held assets in British Columbia and Alberta, and these assets were primarily mortgages.
- 11. WCC provided mortgage administration, capital raising and mortgage brokerage services to the MICs. Another corporation, WCSC, provided business support services, staffing, and office space to the MICs.
- 12. The Trust, WCC and the MICs entered into an Arrangement Agreement whereby:
 - a) The MICs' affairs were rearranged; and,
 - b) The MICs' assets were consolidated into the Trust by way of MIC shareholders exchanging their shares in exchange for units of the Trust (the "Arrangement").
- 13. The main reason for the Arrangement was income tax concerns arising from the MICs' interest in real estate assets because of foreclosure actions. Investors in the MICs received information circulars in support of the Arrangement.

14. On July 14, 2015, the Arrangement was approved by a Court Order granted by this Honourable Court.

15. WIT holds a beneficial interest in assets comprised mostly of mortgages and some real estate holdings, which various Companies in Trust for WIT held.

16. The foregoing is intended as a very brief overview. More detail of the foregoing is contained in the Munir Affidavit filed in these proceedings, a copy of which can be found on the website established by BDO as set out above.

Receiver's Activities Since its Eighth Report

17. On or about September 23, 2022, the Judicial Trustee sent out by email and by ordinary mail the Seventh Semi-Annual Report to each investor. This report provided the Investors with the following:

a) Receiver's activities;

b) Status of various investments made by WIT; and,

c) Investor matters.

Attached as **Exhibit 1** is a copy of the Seventh Semi-Annual Report dated September 23, 2022.

18. On or about February 27, 2023, the Judicial Trustee sent out by email and by ordinary mail the Eighth Semi-Annual Report to each investor. This report provided the Investors with the following:

a) Receiver's activities;

b) Status of various investments made by WIT; and,

c) Investor matters.

Attached as **Exhibit 2** is a copy of the Eighth Semi-Annual Report dated February 27, 2023.

- 19. On March 15, 2023, the Trustee attended an application to address the City of Spruce Grove's Application seeking an Order to set aside the Notice of Disallowance in the Westpoint Investment Trust matter.
- 20. The Trustee instructed its counsel to make a proposal to the City of Spruce Grove (the "City") at the application, and while discussing the proposal, the application was adjourned to allow the Trustee to formalize its proposal and to permit the City some time to consider the Trustee's proposal.
- 21. The City accepted the Trustee's proposed settlement and on April 28, 2023, the Trustee and the City entered into a settlement agreement which was subject to Court approval.
- 22. On July 5, 2023, the Court approved the settlement and ordered that the funds be transferred from WIT to WCC et al for payment. On July 6, 2023, the Receiver issued a cheque for the settlement in the amount of \$134,773.
- 23. On or about September 1, 2023, the Judicial Trustee sent out by email and by ordinary mail the Ninth Semi-Annual Report to each investor. This report provided the Investors with the following:
 - a) Receiver's activities;
 - b) Status of various investments made by WIT; and,
 - c) Investor matters.

Attached as **Exhibit 3** is a copy of the Ninth Semi-Annual Report dated September 1, 2023.

- 24. The Receiver has been able to determine that the property in Atlanta, Georgia, USA is not an asset of the Companies, and no recovery will be possible.
- 25. The Receiver and its legal counsel have now determined that the majority of the writs against various individuals are no longer enforceable due to those individuals filing personal insolvency by either a consumer proposal or a personal bankruptcy, and have not been renewed.

26. For the one individual that has a writ registered against that person, it was determine that based on various searches that this individual has no eligible assets of any value, and as such, no further steps have been taken to enforce the writ.

Receiver's Statement of Receipts and Disbursements

- 27. Attached as **Exhibit 4** is a copy of the Receiver's Statement of Receipts and Disbursements for the Companies up to February 7, 2024.
- 28. As stated in the Eighth Report, as of April 8, 2022, the Receiver had \$4.8 million in trust.
- 29. By Order of this Honourable Court granted April 20, 2022, and filed May 19, 2022, the Receiver was directed to transfer the funds held by the Receiver in trust from its liquidation activities, except for \$400,000, to the Judicial Trustee for the account of WIT.
- 30. The Receiver was also directed to distribute \$300,000 of the amount retained by the Receiver on a pro rata basis to creditors who had substantially complied with the Claims Process Order filed in these proceedings on November 15, 2019, and whose Claims had been accepted by the Receiver ("Accepted Claims").
- 31. The Settlement Agreement entered into as between the City of Spruce Grove and the Judicial Trustee, was approved and the Judicial Trustee was ordered to transfer the sum of \$134,773 from the Judicial Trustee's account to the Receivership account and the Receiver paid this sum to the City in satisfaction of the City's claim.

Professional Fees

32. The Receiver and its legal counsel charged professional fees, excluding GST and disbursements, totalling \$133,432. A summary of invoices is attached as **Exhibit 5**.

33. In the Receiver's view, the services rendered regarding these fees and disbursements have been duly rendered in response to the required and necessary duties of the Receiver and are reasonable in the circumstances. Accordingly, attached as **Exhibit 6** is an Affidavit sworn by David Lewis, on behalf of the Receiver, including a summary and detailed listing of the Receiver's Fees and Disbursements, together with a summary of the fees and disbursements of its legal counsel, supporting the approval of the professional fees and its discharge.

Books and Records of the Company

34. The Receiver is currently in possession of approximately 25 boxes of the Companies' records and five computer towers and one server. There are no directors or offices of WCC as the directors resigned some time ago. As there is no one who is in a position to take possession of these records, the Receiver is seeking court approval to have them destroyed.

Steps for Completion of the Administration of the Receivership

- 35. The following steps need to be completed to complete the administration of the Receivership:
 - a) Pay all outstanding professional fees and pay any remaining funds to Westpoint Investment Trust;
 - b) Destruction of the records in possession of the Receiver; and,
 - c) Any further direction the Court wishes to provide to the Receiver.
- 36. Attached as **Exhibit 7** is the Discharge Certificate indicating all of the above duties have been completed that the Receiver proposes to execute once all of the above steps have been completed

Recommendations

37. The Receiver is seeking the following from this Honourable Court:

a) Approval of the Receiver's activities and conduct as outlined in this Ninth

Report;

b) Approval the Statement of Receipts and Disbursements set out herein;

c) Approval of the passing of accounts for fees and disbursements of the

Receiver and its various legal counsel;

d) Authorizing the Receiver to destroy the books and records of the

Company;

e) Discharging the Receiver; and,

f) Any further direction the Court wishes to provide to the Receiver.

Intended Course of Action

38. If the Receiver's recommendations are approved, the Receiver's proposed

course of action is to:

a) Complete the administration of the various asset realizations; and,

b) Complete the administration of this Receivership, leading to an

application for discharge.

Trustee's Activities Since its Sixth Report

- 11. On September 2, 2022, the Trustee attended court for two matters:
 - a. A claims process; and
 - b. Advice and direction regarding payment to the investors of WIT.
- 12. On September 2, 2022, the Court granted the claim process order (the "Claims Process Order").
- 13. The Claims Process Order excludes the requirement for any "Unitholders" from filing claims. Unitholder is defined as follows:
 - Unitholder means Unitholder as such is defined in the Westpoint Investment Trust and Amended and Restated Declaration of Trust, made as of the 3rd day of September 2015 with retroactive effect to 30th day of June 2015.
- 14. In other words, investors in WIT are not required to prove claims.
- 15. On September 6, 2022, the Trustee mailed out to all known creditors a Notice to Creditors and a blank Proof of Claim form, as required by the Claims Process Order.
- 16. On September 6, 2022, the Trustee posted on its website the Notice to Creditors, as required by the Claims Process Order.
- 17. On September 12, 2022, the Trustee published the Notice to Creditors in the Edmonton Journal and Vancouver Sun, as required by the Claims Process Order.
- 18. On September 13, 2022, the Trustee published the Notice to creditors in the Globe and Mail, as required by the Claims Process Order.
- 19. The Trustee attempted to receive advice and direction regarding the payment to the investors, specifically confirmation that investors requesting a redemption of their units would be paid in priority or if all investors would receive payment proportionately. The Court determined it was premature to decide the matter without knowing the potential claims against the remaining funds.

Receipts and Disbursements

20. The statement of receipts and disbursements from March 8, 2019 to September 23, 2022 is attached as Exhibit 1. The Trustee and Receiver currently have \$4,439,638 for the payment of investors and creditors.

Next Steps

21. The Receiver will be making a Court application shortly after the determination of the amount owing to creditors of WIT. At that application, the Trustee intends to seek court approval for partial or full distribution of the remaining funds being held in Trust.

- 12. The Trustee instructed its counsel to make a proposal to the City of Spruce Grove (the "City") at the application, and while discussing the proposal, the application was adjourned to allow the Trustee to formalize its proposal and to permit the City some time to consider the Trustee's proposal.
- 13. The City accepted the Trustee's proposed settlement and on April 28, 2023, the Trustee and the City entered into a settlement agreement.
- 14. The underlying premise of the settlement agreement is to put the City in the same position it would have been had proper notice of the First Claims Process Order, had submitted a Proof of Claim in accordance with the First Claims Process Order and had participated in the distribution.
- 15. The settlement agreement is subject to Court approval and requires a transfer of \$134,773 from the WIT to the Receiver of WCC and payment of this amount by the Receiver of WCC to the City to satisfy the agreement. This is discussed further in the following paragraphs.

Recent Court Applications

July 5, 2023, Court Application

- 16. On June 29, 2023, the Trustee's legal counsel informed the Trustee that Keely Cameron of Bennett Jones LLP was being retained by a group of unitholders who wished to oppose the method of distribution proposed by the Trustee.
- 17. On July 5, 2023, the Trustee attended an application to address various matters and at which time the Honorable Court granted an Order that:
 - a. Approved the activities of the Trustee;
 - b. Approved the professional fees of the Trustee and its legal counsel;

- c. Approved payment to PWC of \$55,125;
- d. Approved the settlement with the City of Spruce Grove and payment of \$134,773;

- f. Adjourned the discharge of the Trustee;
- g. Set the following timelines for legal briefs regarding the distribution matters as follows:
 - i. July 20, 2023, for the Brief of counsel for the group of investors opposing the method of distribution proposed by the Trustee; and
 - ii. August 15, 2023, for responding briefs.

and,

- h. Directed the Trustee to provide information regarding this application and notice for application on August 30, 2023.
- 18. On July 17, 2023, the Trustee paid the amount approved by the Court to PWC and the City of Spruce Grove.
- 19. On July 19, 2023, the Trustee prepared the First Supplemental Report to the Trustee's Fourth Report.

August 30, 2023, Court Application

- 20. On August 30, 2023, the Trustee attended an application to address the Trustee's proposed method of distribution to investors that was adjourned at the July 5, 2023, application.
- 21. Legal counsel for both parties presented their arguments regarding the Trustee's proposed method of distribution to investors and creditors. The Court reserved its decision. The Trustee is unable to provide a timeline for when a decision will be granted.

- I, David Lewis, of the Hamlet of Sherwood Park, in the Province of Alberta, Insolvency Practitioner, MAKE OATH AND SAY THAT:
- 1. I am a Senior Vice President of BDO Canada Limited ("BDO"), and a licensed insolvency trustee and have been overseeing the day-to-day administrative work in relation to this engagement and, as such, have personal knowledge of the matters hereinafter deposed to, except where stated to be based on information and belief, and whereso stated, I do verily believe the same to be true.

- 2. On March 8, 2019, the Court of Queen's Bench of Alberta (the "Court") granted an Order (the "Order") appointing BDO Canada Limited as an Interim Receiver in respect of Westpoint Capital Corporation ("WCC"), Westpoint Capital Management Corporation ("WCMC"), Westpoint Capital Services Corporation ("WCSC"), Westpoint Syndicated Mortgage Corporation ("WSMC"), Canadian Property Direct Corporation ("CPDC"), Westpoint Master Limited Partnership ("WMLP"), River's Crossing Ltd. ("RCL"), 1897869 Alberta, Ltd. ("869"), 1780384 Alberta Ltd. ("178"), 1897837 Alberta Ltd. ("837").
- 3. On April 10, 2019, the Court granted an Order (the "Receivership Order") appointing BDO Canada Limited as Receiver ("BDO" or the "Receiver") of the companies referred to in the previous paragraph. On May 30, 2019, the Court granted a further Order, amending the Receivership Order to add The Village at Paldi Ent. Ltd. ("Paldi") as a party in receivership (the companies in receivership are collectively referred to as the "Companies").
- 4. This Affidavit is in support of an Order approving BDO's fees in respect of its role as Receiver of WCC et al., excluding River's Crossing Ltd. ("RCL"). The reason for excluding RCL is that Conexus Credit Union was the first mortgage on the RCL in Cranbrook, British Columbia. As such, the Receiver kept a separate accounting and separate professional fees.
- 5. The statements of fees and disbursements of BDO in respect of WCC et al. are attached as **Exhibit** "A".
- 6. A detailed summary of BDO's fees and disbursements relating to its administration of the estate of WCC et al. can be found at **Exhibit "B"**.
- 7. The summary, Exhibit B provides a full disclosure of fees and disbursements incurred and expended by BDO for the period of April 10, 2019 to Close.
- 8. The statements of fees and disbursements of BDO's legal counsel, Miller Thomson LLP and Bryan & Company LLP, in respect of WCC et al. are attached as **Exhibit "C"**.
- 9. In relation to BDO's fees, the detailed report of its fees and disbursements sets out the daily time and work performed by each employee of BDO working on the estate of WCC et al. The hourly rates and charges applied are the normal rates and charges for personnel employed by BDO when administering an estate.
- 10. I believe and submit that the hourly rates are reasonable and comparable to the hourly rates of other accounting firms within the City of Edmonton of equivalent competence and expertise in the restructuring and insolvency area.
- 11. As per paragraph 18 of the Receivership Order, the Receiver and its legal counsel have a first charge on the property of WCC et al. as security for their reasonable fees and disbursements in respect of those proceedings (the "Receiver's Charge").
