

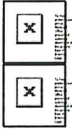

We act as counsel for BDO Canada Limited ("BDO") in its sole capacity as trustee in bankruptcy (the "Trustee") of the Estate of Richard Jaggard (the "Estate").

Please be advised that for the purpose of liquidating and dissolving 941996 Alberta Ltd. ("941 AB") a company that was solely owned by Mr. Jaggard prior to his death and bankruptcy, the Trustee applied to have BDO Canada Limited appointed as liquidator (the "Liquidator") of 941 AB. We note that we also act on behalf of BDO in its capacity as Liquidator of 941 AB.

The Liquidator has now completed the liquidation and applied to the Court for an Order approving its activities, professional fees, and approving distribution of available residual funds in 941 AB to the Estate. A copy of the Order is enclosed for service upon you.

In particular, we draw your attention to paragraph 10 of the Order which requires that any interested party that wishes to set aside or vary the Order must notify BDO of such intention within one week of being served with a copy of this Order. Justice Hollins had directed this clause be inserted as proven creditors in the bankruptcy had not been given notice of the liquidation proceedings.
