Fourth Report of BDO Canada Limited, as Receiver of 655873 N.-B. Inc., operating as Rivière-Verte Rite Store

- I, JASON BREEZE, of Halifax, Nova Scotia, say as follows:
 - I am a Licensed Insolvency Trustee and Vice President of BDO Canada Limited
 ("BDO Canada") Receiver of 655873 N.-B. Inc., operating as Rivière-Verte Rite
 Store (the "Company"). As such I have personal knowledge of the matters herein,
 except where otherwise stated.

The within report is supplemental to my three prior reports. The purpose of this fourth report is to provide the Court and the parties with background on the sums received from the Company by the Secured Creditor, Royal Bank of Canada ("RBC") and the application of those funds on account of the indebtedness of the Company to RBC. This report will further detail the costs incurred by RBC on account of the Company from both prior to and following the appointment of BDO Canada by Order of this Court dated February 11, 2016.

Indebtedness and Payments on Account

- 3. RBC issued demand for payment to the Company by demand letter dated March 25, 2014, which demanded repayment of all debts as of February 12, 2014. As at February 12, 2014, the Company was indebted to RBC as follows:
 - a) \$10,025.21 on account of a revolving line of credit;
 - b) \$577,066.40 on account of a term loan;
 - c) \$15,899.79 on account of a corporate visa; and
 - d) Together with costs which were at that point unspecified.

I attach and mark as Exhibit 1 is a copy of the RBC demand dated March 25, 2016, together with the RBC loan screens from which the information was taken.

- 4. Following demand, the Company continued to make certain payments on account. These payments were detailed in the Affidavit of Angella White, filed January 26, 2016. I attach and mark as Exhibit 2 a copy of Ms. White's Affidavit, without Exhibits.
- On September 20, 2016, I met with Mr. Daniel Johnson, representing the Company.
 Mr. Johnson provided me with a bank draft in the amount of \$100,000 payable to RBC, to be paid on account.

- 6. On November 7, 2016, Mr. Daniel Johnson, representing the Company, provided RBC's solicitor, George L. Cooper of Cox & Palmer, with two bank drafts totaling \$50,000, to be paid on account.
- 7. I am informed by RBC and believe that the \$100,000 received on September 20, 2016 was applied as follows:
 - a) \$9,584.68 on account of the revolving line of credit;
 - b) \$80,908.86 on account of the term loan; and
 - c) \$9,506.46 on account of the corporate visa (which has been converted to a term loan).
- 8. I am informed by RBC and believe that the \$50,000 received on November 7, 2016 was applied against the remaining term loan, reducing the balance of the term loan to \$412,705.06, as of November 28, 2016.
- 9. I attach and mark as Exhibit 3 copies of RBC printouts of loan screens detailing the amounts owed as at November 28, 2016, together with RBC Loan Histories for all of the Company's loans:
- 10. I am informed by RBC and believe that in addition to the above indebtedness, Mr. Johnson also owes RBC, in respect of a corporation related to Mr. Johnson, the sum of \$6,431.84, which he has agreed to pay to RBC from the proceeds of his proposed refinancing.

Costs Incurred by Royal Bank of Canada

11. In addition to the Company's indebtedness detailed above, the Company is also responsible to repay RBC for the costs it has incurred in connection with the indebtedness. These costs include:

- a) fees paid to BDO Canada, both before and after the date of appointment (February 11, 2016);
- b) fees paid to Cox & Palmer, both before and after the date of appointment;
- c) real property appraisal fees;
- d) fees paid to Fundy Engineering on account of a Phase 1 and Phase 2 Environmental Impact Assessment;
- e) fees paid to Castle Appraisals Ltd. for personal property appraisals and attendances in Edmundston in anticipation of a full receivership order being granted by this Honourable Court; and
- f) sundry other fees, disbursements and taxes.

12. A summary of the fees charged and paid to date is as follows:

I attach and mark as Exhibit 4 copies of the BDO Canada and Cox & Palmer invoices referred to above, together with details of disbursements and taxes.

13. As appears from a review of the invoices, the sum of \$45,635.25 was billed prior to the initial order dated February 11, 2016.

14. In addition to the amounts set out above, BDO Canada has unbilled fees of \$9,230.01 (inclusive of HST at 13%); Cox & Palmer has unbilled fees, taxes and disbursements of \$10,435.81 and Castle Appraisals Ltd. has billed and unpaid account totaling \$2,612.80. Once all amounts are billed and invoiced to RBC, RBC's total costs incurred will be \$130,600.14.

15. I make this Report in good faith for the purposes stated above.

AFFIDAVIT

- I, ANGELLA WHITE, of the City of Toronto, Province of Ontario, MAKE OATH AND SAY:
- 1. I am a Manager, Special Loans Group, with the Royal Bank of Canada ("RBC"), the Applicant herein, and as such have knowledge of the matters to which I herein depose, except where otherwise stated to be by way of information and belief. I am authorized to make this Affidavit.
- 2. The Respondent, 655873 N.-B. Inc. (the "Company"), is justly and truly indebted to RBC (as of January 5, 2016) as follows:
 - (a) Pursuant to a Loan Agreement, dated April 4, 2012, a copy of which is attached hereto as Exhibit "A", consisting of:
 - i) an Operating Line of Credit, which, as January 5, 2016, had an outstanding balance of \$11,089.11;

- ii) a Fixed Term Loan, which, as at January 5, 2016, had an outstanding balance of \$554,904.71;
- iii) a Business Visa account, which, as at January 5, 2016, had an outstanding balance of \$14,956.91; and
- iv) realization account, which, as at January 5, 2016, had an outstanding balance of \$34,473.64,

(collectively, the "Indebtedness").

- 3. RBC holds security for the Indebtedness as follows:
 - (a) a General Security Agreement, dated April 13, 2012, a copy of which is attached hereto as Exhibit "B"; and
 - (b) a Collateral Mortgage, dated April 16, 2013, a copy of which is attached hereto as Exhibit "C",

(collectively, the "Security Agreements").

- 4. As of March 25, 2014, RBC duly demanded in writing that the Company repay its Indebtedness to RBC and duly provided notice of its intention to enforce its security, pursuant to the *Bankruptcy and Insolvency Act*. Attached and marked as Exhibits "D", "E" and "F" are copies of RBC's demand letters to the Company and to Daniel Johnson and Remorquage Nord-Ouest Towing Inc., in their capacity as Guarantors of the debts and obligations of the Company.
- 5. Following demand, RBC has taken judgment against the guarantors.
- 6. The Company carries on business as a retail gas bar, campground and convenience store.
- 7. The Company has admitted its indebtedness to RBC and has made, since the date of demand and judgment, repeated commitments to RBC that it would repay the indebtedness in full. At no time has it done so; however, it has made the following payments on account:

- 8. Beginning in March of 2014 and continuing through to December, 2015, RBC has made attempts to inspect the collateral pledged as security for the Indebtedness, most notably the lands and building located at or near Davis Road and Route #2, Rivière-Verte, New Brunswick, identified as PID#'s 35295526, 35297118 and 35297126 (the "Real Property").
- 9. It has become clear, based on the elapse of time and the numerous failed promises of the Company, that in order to be repaid the Indebtedness, RBC will be forced to enforce its Security, including its Security over the Real Property.
- 10. Prior to enforcing security over real property, RBC generally requires that the real property be appraised and that environmental reports be obtained in order to assure RBC that it will not inadvertently assume environmental risks under the Clean Environment Act and other statutes. In the case of the Real Property owned by the Company, same has been used in part as a gas bar and so RBC has been particularly cautious in its approach to realization.
- 11. RBC has obtained two appraisals of the Real Property, the contents of which are confidential. RBC has further, as of March, 2015, obtained a Phase I Environmental Site Assessment prepared by Fundy Engineering. The Phase I concluded in part:

"The Phase I ESA completed by Fundy Engineering at the properties on Davis Road, Rivière-Verte, NB determined that the properties do not contain any actual environmental concern; however, there are potential concerns associated with underground storage tanks, ozone depleting substances and watercourses. Further investigation is recommended regarding the current underground storage tanks to confirm or deny any impacts to the subsurface soils and/or groundwater. in the form of a Phase II Environmental Site Assessment." [Emphasis Added]

A copy of the Phase I is attached hereto as Exhibit "G".

- 12. Upon receipt of the Phase I and the recommendation that a Phase II assessment be completed, RBC, through its solicitors, made numerous attempts to obtain access to the Real Property for the purposes of completing a Phase II. The Company denied all requests for access.
- 13. After the Company refused to provide RBC with access to the Real Property, RBC appointed BDO Canada Limited as a limited purpose receiver, in accordance with an appointment letter dated November 12, 2015, a copy of which is attached hereto as Exhibit "H".
- 14. I am informed by Jason Breeze of BDO Canada Limited that he, together with Greg Derrah of Fundy Engineering Limited and Elliott Offman, personal property appraiser, attended at the Real Property on December 1, 2015, served the Notice of Receiver (a copy of which is included in Exhibit H hereto) on the principal of the Company and were denied access to the Real Property. As a result, a Phase II has yet to be completed.
- 15. In all of the circumstances RBC requests this assistance of this honourable court to gain access to the Real Property as set out in draft order attached to the Notice of Applicant in.


