

on hand as of June 12. This larger than planned draw was due to the timing of the draw coinciding with the end of the second week.

8. The Company has been actively pursuing a sale of its principal asset (the sailing ship Caledonia (the "Vessel")) and as of July 4, 2008, had listed the Vessel with 9 brokers for sale at a purchase price of €8.5 million Euro at a range of commissions between 7 and 10 percent. These brokers service a number of markets in North America, Europe, and the Asia-Pacific areas.
9. In addition to listing the Vessel for sale, the Company has offered the Vessel for long term charter as a standby vessel, inshore accommodation vessel and chase vessel; the Company has also submitted a bid for the Vessel's use in connection with a film production, both as of July 4, 2008.
10. The Company has received requests for information from the listing brokers but has not yet received any offers for purchase or charter of the Vessel.
11. In addition to the foregoing activities related to a potential sale or charter of the Vessel, the Company has been actively seeking new sources of equity and additional financing to allow it to finalize a plan of arrangement to place before its creditors and permit it to continue operating beyond its protection under the CCAA. The Company has had preliminary discussions with one potential source of equity and debt financing and discussions are ongoing with parties, including some of the Senior Secured Creditors.
12. As described above, the Company has been engaged in the process of restructuring its business and operations in order to formulate a plan of arrangement that will balance the interest of all of the Company's stakeholders. It is my belief that, throughout this process, the Company has acted in good faith and due diligence, and is my intention to cause the Company to continue to so act.
13. An extension of the Stay Termination Date set out in the Initial Order would allow the Company to accomplish the following:
 - (a) Continue to generate revenue through sales from operations and obtain bookings for the fall and winter seasons thereby continuing the Company's penetration of its target market;
 - (b) Continue its efforts to raise capital and debt to permit the success of the restructuring; and
 - (c) Allow the Company (through its brokers and agents) to continue the market of the Vessel for either sale or charter.
14. I believe that if the Stay Termination Date is not extended, some of the creditors of the Company will commence proceedings against the Company through the enforcement of security, which would be prejudicial to the interests of the Company and would significantly impair the Company's ability to complete a successful restructuring.

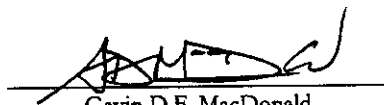
