1. FIFTH REPORT OF THE MONITOR – GENERAL COMMENTS

- 1.1. Pursuant to an Order (“Initial Order”) of the Supreme Court of Nova Scotia (“the Court”) dated June 27, 2008, BDO Dunwoody Goodman Rosen Inc. was appointed as the Monitor (“the Monitor”) pursuant to an application made by Canadian Sailing Expeditions Inc. (“CSE”) to seek protection under the Companies’ Creditors Arrangement Act (“CCAA”).
- 1.2. The following is a summary of the Orders granted by the Court which form the basis of the CCAA proceeding of CSE as has occurred to date:
 - Initial Order granted on June 27, 2008 by The Honorable Justice Gerald R.P. Moir;
 - First Debtor-in-Possession (“DIP”) Financing Order granted on July 4, 2008 by The Honorable Chief Justice Joseph P. Kennedy;
 - Consent Order extending the Stay of Termination Date from July 24, 2008 to July 25, 2008 granted on July 24, 2008 by The Honorable Justice John D. Murphy;
 - Order Extending the Stay of Termination Date to September 3, 2008 granted on July 25, 2008 by The Honorable Justice John D. Murphy;
 - Second Debtor-in-Possession (“DIP”) Financing Order granted on August 13, 2008 by The Honorable Justice Arthur W.D. Pickup;
 - Claims Process Order granted on August 13, 2008 by The Honorable Justice Arthur W.D. Pickup;
 - Order Extending the Stay of Termination Date to October 17, 2008 granted on September 5, 2008 by the Honorable Justice A. David MacAdam (attached as Exhibit 1).
- 1.3. To date, the Monitor has prepared and filed four detailed reports and one supplementary report with the Court as follows:
 - Monitor’s First Report dated July 2, 2008;
 - Monitor’s Second Report dated July 21, 2008;
 - Monitor’s Supplementary Report dated July 24, 2008;
 - Monitor’s Third Report dated August 8, 2008;
 - Monitor’s Fourth Report dated August 28, 2008.
- 1.4. Subsequent to the date of the Monitor’s Fourth Report of August 28, 2008, the Monitor advises that we have undertaken or we have been involved in various activities which may generally be described as follows:
 - We have continued, on a regular basis, to be in contact and communication with Douglas Prothero, the CEO of CSE, and/or certain members of the CSE staff, CSE’s legal counsel, and counsel to the Monitor. The subject matter of the majority of these contacts and communications are referred to elsewhere herein.

- We continue to field a number of communications from creditors as to the status of the CCAA proceeding of CSE and we have responded to each of these inquiries on a timely basis, including answering the questions about pre-filing obligations and post-filing supply of goods and services, and dealings with respect to the filing of creditors' claims under the Claims Process and other questions that creditors may have had.
- Each week, pursuant to the regime we have established with CSE, we receive the Cash Flow Report and various materials related thereto from CSE and we perform a limited review and reconciliation of the information provided, seek explanations for various questions or variances, recommend changes where appropriate, and provide an email report and the Cash Flow Report to those creditors and parties who have requested same.
- We have reviewed confidential written reports provided to us by Mr. Prothero with respect to progress made toward the determination of the elements and form of a CCAA Plan of Arrangement and we met with Mr. Prothero to fully explore the status of progress of a Plan of Arrangement.
- The Monitor has provided his input to CSE and its counsel as to the form of and certain aspects of a Plan of Arrangement and the CCAA process.
- We have had a number of communications and discussions with CSE, its counsel, and Monitor's counsel regarding various aspects of the CCAA process, including DIP financing, extension of the Stay of Termination Date, Cash Flow, Claims Process, and the elements and positions that may be considered for a Plan of Arrangement.
- The Monitor attended the Court hearing held on September 5, 2008 with respect to the extension of the Stay of Termination Date to October 17, 2008.
- The Monitor has had communications and discussions with certain secured creditors, CSE, and a potential purchaser for the *Hawk*.
- During the period since the last report, the Monitor's staff spent considerable time on the Claims Process, receiving and reviewing claims and related materials, contacting creditors and CSE re differences in claims, reconciling claims, and issuing acceptance or dispute notices.
- With respect to claims in dispute, the Monitor resolved a number of such disputed claims and, in consultation with CSE staff, worked the number of disputes to be considered by the Claims Officer down to two claims.
- The Monitor communicated and met with the Claims Officer to provide materials for his two hearings.
- The Monitor attended at two claims dispute hearings before the Claims Officer, and said claims were resolved with the input of the Monitor.

- The Monitor has had communications with and met with the present DIP lender and possible future DIP lenders.
- The Monitor received a Plan of Arrangement and provided comments to CSE and its counsel.
- The Monitor received and reviewed comments from its counsel, Mr. Holm.
- The Monitor has attended to and reviewed a number of other matters and documentation which may not otherwise be referred to herein.

2. CASH FLOW, CASH FLOW PROJECTIONS, AND DEBTOR-IN-POSSESSION (“DIP”) FINANCING

- 2.1. Each of the previous Monitor’s Reports to the Court included the weekly Cash Flow Reports (Cash Receipts and Disbursements) for the most recent week with accumulation for the full CCAA period to the end of that weekly reporting period. As well, certain of the Monitor’s Reports also contained other monthly Cash Flow Projections. The Monitor commented on each of these documents as they had been presented at the time.
- 2.2. We previously advised the Court that the Monitor has established a regime and timing related to the provision of and a limited review of the Weekly Cash Flow information as provided by CSE to the Monitor. The Monitor has provided full particulars of the regime in its previous reports. The Monitor does not audit the data provided by CSE, nor do we express any opinion as to the accuracy or completeness of the data.
- 2.3. Each week, the Monitor reports on the status of the Cash Flow and provides a copy of the Cash Flow Report to the creditors and other parties who had requested this data. The most recent Weekly Cash Flow Report is attached as Exhibit 2 and is the Weekly Cash Flow Report (Weekly Cash Receipts and Disbursements) for Week #15, being the week from October 6, 2008 to October 12, 2008 inclusive, and including the cumulative position for the first 15 weeks of the CCAA proceeding through to October 12, 2008. The Monitor’s comments in summary with respect to Exhibit 2 are:

- As *The Caledonia* is laid up, there is no revenue in Week #15.
- For the 15 weeks to October 10, 2008, revenue is \$40,482 greater than plan.
- Expenses in Week #15 are \$28,741 less than plan.
- Expenses for the 15 weeks to October 10, 2008 are \$203,472 less than plan.
- DIP loans are \$660,000 with no DIP funds being deposited in Week #15.
- CSE has requested a DIP loan advance which had not been delivered at this writing.
- Trust funds for customer fares paid in advance increased significantly in Week #15 as follows:

Canadian fares in trust	\$ 69,032.68
U.S. fares in trust	\$ 2,220.00

- 2.4 The present DIP financing as approved to be provided by Growthworks Atlantic Venture Fund Limited (“Growthworks”) is estimated at \$813,145 pursuant to the Exhibit 1 Order. To date, \$660,000 is drawn by CSE against the DIP loan as reflected in Exhibit 2. CSE has requested a further DIP loan advance as against approved DIP financing, but the DIP loan funds had not yet been delivered at the time the Cash Flow Report was prepared. The DIP loan funding advance made by CSE was for the balance of available funds of \$153,145. The amount to be advanced, we understand, will be \$145,687, the difference of \$7,458 being interest payable.

- 2.5 Continuing the CSE proceeding, either on an operating or lay up basis with respect to *The Caledonia*, will require more DIP funds. The Monitor has requested that CSE provide updated Cash Flow Projections in this regard under various scenarios. To date, these updated Cash Flow Projections have not been received, but will be needed if there is to be an application for further DIP financing.
- 2.6 As indicated in the Monitor's Fourth Report, it was CSE's intention to lay up *The Caledonia* for annual refit and certification in the month of October, so no revenue was projected for that month. This lay up has taken place and the ship is presently tied up in Lunenburg. After lay up, and the passing of hurricane season, it is planned that *The Caledonia* would sail to the Caribbean for its winter cruising schedule or, depending on other factors, it may stay laid up.
- 2.7 If *The Caledonia* remains laid up in anticipation of a sale, CSE believes it would be more productive to move it to Florida both for preservation purposes and the proximity to the global market.
- 2.8 CSE, at the request of the Monitor, has prepared an estimate of the costs of lay up and removal to Florida in comparison to lay up in Nova Scotia. Attached as Exhibit 3 is a schedule reflecting the comparison of these costs. Notwithstanding that the lay up costs plus removal to Florida are \$58,000 more than keeping the vessel laid up in Nova Scotia, CSE believes a greater realization can be obtained by moving *The Caledonia* to a marketplace which is more accessible to interested parties.
- 2.9 If *The Caledonia* stays laid up and does not sail in the Caribbean in the winter months, then the fares paid in advance will have to be returned to the passengers and there likely would be considerable ill will in the industry and damage to CSE's reputation.
- 2.10 To date, fares paid in advance are all held in separate U.S. dollar and Canadian dollar trust accounts. This amount represents the advances that would have to be returned to customers if none of the Caribbean sailings occurred. The amounts of customer fares paid in advance as reflected on the depositor's list are:

Canadian customer fares paid in advance	\$ 194,043.65
U.S. customer fares paid in advance	\$ 32,785.83

3. CLAIMS PROCESS

3.1. Section 3 of the Monitor's Fourth Report provided a summary of the Monitor's work in setting up the Claims Procedures as was required by the Claims Process Order of August 13, 2008.

3.2. Pursuant to the August 13, 2008 Claims Process Order, the Monitor and others had to adhere to certain critical path timing milestones. These milestone dates, some of which occurred after the date of our Fourth Monitor's Report, are:

- By August 21, 2008 Monitor sent out Claims Package
- By August 22, 2008 Monitor published advertisements in Halifax Chronicle Herald and Toronto Globe & Mail
- By September 11, 2008 Claims Bar Date
- By September 18, 2008 Monitor sent Notices of Disallowance or Revision
- By September 29, 2008 Notices of Dispute to Monitor's Disallowance delivered to Monitor
- By October 15, 2008 Any hearings before the Claims Officer to be held

3.3. The Monitor confirms to the Court that all timing milestones have been complied with. Attached as Exhibit 4 is the Proofs of Claim Register reflecting the status of all claims as they were recorded in the CSE records (or not recorded, but filed). Exhibit 4 shows the claims filed, not filed, amended, disputed, and resolved.

3.4. The Monitor confirms that there were no claims filed after the Claims Bar Date which had to be accepted by Monitor's discretion. Only one claim was received after September 11, 2008 and it was received on October 8, 2008 and was rejected by the Monitor.

3.5. The Monitor advises that there were two claims that became subject to the claims dispute process and which were referred to the Claims Officer, Richard Cregan, for resolution. Hearings on both disputes have taken place. Both claims have now been resolved or decided upon and the resolutions are reflected in Exhibit 4.

- 3.6. The Monitor advises that the subject of the post-filing claims (those incurred after June 27, 2008) and the process for dealing with such claims needs to be the subject of a future Order of the Court, and CSE has been advised of this matter by the Monitor.
- 3.7. The Monitor also advises that he has indicated to CSE that related to the Claims Process and the development of a Plan of Arrangement is the issue of classification of creditors for voting purposes, on which it may be necessary to have direction from the Court.

4. STATUS OF PLAN OF ARRANGEMENT UNDER CCAA

- 4.1. As indicated in previous reports, under Section 11(6) of the CCAA, the Monitor needs to be confident that the burden of proof to satisfy the Court on granting an application is on CSE so as to satisfy the Court that:
- (a) circumstances exist that make an Order appropriate; and
 - (b) CSE has acted in good faith and are continuing to act in good faith and with due diligence.
- 4.2. In the discussions that the Monitor has had with officials of CSE and its counsel, the prospects for a Plan of Arrangement continue to be achievable. The fact continues to remain that any CCAA Plan of Arrangement is likely to include any of the following actions or combinations where possible:
- the sale of the vessel *The Caledonia* by way of an aggressive marketing plan; or
 - the long-term charter of the vessel *The Caledonia*; or
 - an injection of new capital funds or a conversion of debt to equity and/or write-downs and participation from certain secured creditor interests.
- 4.3. Due to the nature of the business and the assets of CSE, the Monitor continues to believe that whatever form of Plan of Arrangement as may be established, it will continue to take some time to determine the major elements of the Plan of Arrangement and it will likely take some further time thereafter to achieve the desired result.
- 4.4. Mr. Prothero, CEO of CSE, has met with the Monitor on a number of occasions and has provided the Monitor with seven written updates as to actions he has undertaken which will lead to the achievement of key elements of a Plan of Arrangement. These seven confidential written reports as provided to the Monitor are dated July 10, 2008, July 23, 2008, August 2, 2008, August 19, 2008, August 25, 2008, September 16, 2008, and October 6, 2008. Each report reflects a trend that CSE's activities are producing contacts and opportunities that, if given the time to flush out, may crystallize into a key program that will launch the Plan of Arrangement.
- 4.5. The Monitor believes that the details of the actions as initiated by CSE to date must continue to be kept confidential so as to protect the ability to negotiate various matters.
- 4.6. The reports from Mr. Prothero to the Monitor reflect that certain brokers have listed *The Caledonia* for sale at 8.5 million Euros (approximately \$13,500,000 Canadian). Certain of the brokers have already identified possible purchasers and, in some cases, the interested parties have inspected the ship. Others are expected to do the same in the next few days. The feedback about the condition of the vessel has been positive.

- 4.7. Mr. Prothero's reports also indicate that certain brokers have been approached for charters in the national resource sectors. There is nothing new in this area at the moment, with the exception of a bid that has already been sent and for consideration by a possible chartering party.
- 4.8. The Monitor is advised by Mr. Prothero's reports that approaches have been made to a number of joint venture or equity partners and these communications are ongoing. Mr. Prothero had the opportunity to meet with a number of parties on a joint venture or equity partner basis and more than one of these contacts appears to be interested in participating with CSE in a go forward plan. Certain of these parties have already inspected *The Caledonia*. In reviewing Mr. Prothero's reports, there appear to be six (6) different parties in the category of joint venture or equity partner who are considering *The Caledonia* opportunity. It appears to be the case that each of these parties has its own partners or investors or lenders to consult with before final investment decisions can be communicated.
- 4.9. The Monitor is still advised by CSE that some preliminary discussions have been held with Growthworks Atlantic Venture Ltd. ("Growthworks") about the conversion of some or all of their debt position to equity, but we caution that we understand that no decision or final commitment has been made by Growthworks in this conversion. Any such conversion, when and if agreed to, would then become an important element in the Plan of Arrangement. The Monitor has confirmed this consideration by Growthworks with its president.
- 4.10. The Monitor has been provided with a copy of a confidential business plan (for greater certainty, not the Plan of Arrangement) which has been prepared by CSE to assist it in its discussions with potential investors. This business plan may still need some work with respect to historical financial statements and updated Cash Flow Projections.
- 4.11. The vessel *Hawk* continues to be laid up in Sheet Harbour. There are certain fixed costs to keeping the *Hawk* in this state, including insurance, wharfage, security, power, etc. In the past two weeks, CSE was approached by a party to purchase the *Hawk* for scrap value. Consents to make the sale were obtained from the Monitor, Growthworks, and Nova Scotia Business Inc. ("NSBI"). In the end, the written offer as agreed to by CSE was amended by the purchaser such that the revised agreement was not in CSE's best interests and the sale was not concluded.
- 4.12. The Extension Order of September 5, 2008, attached as Exhibit 1, requires that CSE file its Plan of Arrangement by October 15, 2008 or, if not filed, CSE must convince the court that there are reasonable grounds why the Plan of Arrangement could not be filed. As previously indicated, the Monitor has had certain discussions and communications with Mr. Prothero and CSE's counsel with respect to various aspects

of the Plan of Arrangement. Over the Thanksgiving weekend, the draft Plan of Arrangement was emailed to the Monitor.

- 4.13. The Monitor has today had the opportunity to review a draft Plan of Arrangement and has, along with its counsel, provided comments to CSE and its counsel. The Monitor will be available at the October 17, 2008 hearing should the Court wish us to comment further on any Plan of Arrangement.
- 4.14. Because of the activities and the materials provided to the Monitor by CSE and the due diligence previously performed by the Monitor to the extent possible on these materials, the Monitor is satisfied that CSE's management has acted and has continued to act in good faith and with due diligence in bringing forth elements that are required for a workable Plan of Arrangement to be considered by the creditors.
- 4.15. The draft Plan of Arrangement does not deal with the details regarding post-filing creditor claims, voting and creditor classes, a creditors meeting, and the Plan of Arrangement implementation. These matters will need to be "fine tuned" as the Plan of Arrangement is finalized for issuance to creditors for their consideration.
- 4.16. The Monitor understands that CSE intends to share the draft Plan of Arrangement with certain creditors prior to the October 17, 2008 hearing in anticipation of receiving comments which CSE may consider in order to finalize the Plan of Arrangement for filing with the Court.

5. COMPANIES' CREDITORS ARRANGEMENT ACT ("CCAA") PROFESSIONAL FEES

- 5.1. As set out in previous reports of the Monitor, Paragraph 30 of the Initial Order provides for the payment of the reasonable fees and disbursements of the Monitor (including the reasonable solicitor and client fees and disbursements of any counsel retained by the Monitor) and the reasonable solicitor and client fees and disbursements of counsel to CSE.
- 5.2. Paragraph 31 of the Initial Order provides that the Monitor, counsel to the Monitor, and CSE's counsel, as security for their reasonable professional fees and disbursements incurred both before and after the making of the Initial Order in respect to the CCAA proceedings, were granted a charge against all present and future property of CSE in the form of an Administration Charge, such charge not to exceed \$300,000 without further Order of the Court. The Monitor continues to believe that there is no reason to seek an increase in the Administration Charge.
- 5.3. Attached as Exhibit 5 is a schedule of the details of the CCAA professional fees including those which are subject to the Administration Charge where they are unpaid. Exhibit 5 reflects total fees (including disbursements and HST) as billed (\$168,615.74) and indicates which ones are paid (\$162,199.59) or are unpaid (\$6,416.15), as the case may be as of October 14, 2008, although the Monitor notes that due to timing differences in the receipt of payment for fees in relation to the preparation of this report, certain fees reflected as unpaid may indeed be paid.
- 5.4. Pursuant to Paragraph 19 of the DIP Order of July 4, 2008, and hence the Second DIP Order of August 13, 2008, the priority of the Administration Charge referred to in Paragraph 3.3 therein is limited, firstly, to \$75,000 and is then, secondly, intersected by the DIP Charge ("DIP Loan"), and then, thirdly, the remaining Administration Charge has next priority. As at the date of this present report, the \$6,416.15 would be the amount subject to the Administration Charge.

6. RECOMMENDATIONS

- 6.1. The Monitor recommends to This Honorable Court that the Stay of Termination Date pursuant to this present CCAA proceeding be extended and continued to on or before November 28, 2008.
- 6.2. Whereas at the time of delivery of this report to the Court, the Monitor has received and reviewed a draft Plan of Arrangement and we understand that it has not yet been filed with the Court, the Monitor recommends that CSE be ordered to file such Plan of Arrangement with the Court by October 24, 2008, assuming that the Plan of Arrangement has not been filed by October 17, 2008 and an Order of Extension of the Stay of Termination Date has been granted.
- 6.3. The Monitor recommends to This Honorable Court that where CSE wishes to continue the CCAA proceeding and whereas additional DIP funds appear to be required, CSE needs to make a third application for DIP financing which the Monitor recommends be made on or before October 24, 2008, subject to the Court extending the Stay of Termination Date.
- 6.4. The Monitor recommends to This Honorable Court that subject to CSE filing its Plan of Arrangement with the Court, and being granted the extension of the Stay of Termination Date referred to in Paragraph 6.1 above, that CSE make further application(s) to the Court:
 - a) to establish a process for the filing of post-filing CCAA claims (post June 27, 2008); and
 - b) if deemed necessary by CSE, to establish or seek direction with respect to the classes of creditors for the purpose of voting at the meeting; and
 - c) to establish a process for the notification of and conduct of the meeting of creditors and the voting thereat.
