1.0 INTRODUCTION AND PURPOSE OF REPORT

1.1 Introduction and Purpose

- 1.1.1** This is the Supplement to the Second Report (the “**Supplemental Report**”), dated June 5, 2018, of the Interim Receiver of the Property of InPost. All capitalized terms in this Supplemental Report that are not otherwise defined have the meanings set out in the Second Report.
- 1.1.2** The purpose of this Supplemental Report is to provide an update on the Interim Receiver’s activities in respect of removing the APMs from U Can Universal Inc.’s (“**UCan Universal**”) premises.

2.0 INTERIM RECEIVER'S ACTIVITIES

2.1 Removal of the APMs from U Can Universal Inc.

- 2.1.1 As discussed in the Second Report, the Interim Receiver obtained final proposals from McWilliams and Ontario Bollards in respect of the removal and storage of the APMs and from the Retailers' premises. Since the date of the Second Report, the Interim Receiver obtained \$400,000 in funding from Integer and entered into agreements with McWilliams and Ontario Bollards for their services.
- 2.1.2 On Friday June 8, 2018, the Interim Receiver met with representatives of McWilliams and UCan Universal to discuss the removal of the approximately 30 APMs and parts (together, the "Stored APMs") currently warehoused at UCan Universal's warehouse at 55 Brown's Line, Etobicoke. At that meeting it was clear that McWilliams would be able to remove all of the Stored APMs from UCan Universal's premises by no later than Friday June 15, 2018. This would be possible if McWilliams commenced removal on Tuesday June 12, 2018, which it did. Accordingly, the Interim Receiver prepared a payment for June 1 to 15 for storage costs based on UCan Universal's June 2018 invoice to the Interim Receiver.
- 2.1.3 Mr. Richard Trejgo, the CEO and President of UCan Universal, communicated to the Interim Receiver that only UCan Universal's own employees would be permitted to move the Stored APMs within UCan Universal's warehouse and that UCan Universal would charge certain rates per hour for their employees. The Interim Receiver requested that UCan Universal provide the Interim Receiver with an estimate of those costs so that the Interim Receiver could pay those costs to UCan Universal, along with the rent to June 15, 2018, on Tuesday June 12, 2018. The Interim Receiver made both of those payments.
- 2.1.4 On Monday, June 11, 2018, Dentons received correspondence from Teplitsky Colson LLP, counsel to UCAN Post Inc. ("UCAN Post"), the minority shareholder of InPost.¹ Included in the covering letter, and the accompanying list of 25 questions, is a statement that UCan Universal would have warehoused the APMs at a lower price than McWilliams. The Interim Receiver was asked to explain, among other things, why it made the decision to move the Stored APMs into storage with McWilliams.
- 2.1.5 Mr. Trejgo, on various occasions throughout these proceedings, consistently and unequivocally stated that UCan Universal does not want the Stored APMs at their warehouse and does not have room for them as they had released a portion of the warehouse space back to their landlord. Mr. Trejgo communicated to the Interim Receiver that the Stored APMs were to be removed as soon as possible. Attached, as **Appendix A** to this Supplemental Report, is a copy of an email from Mr. Trejgo dated February 15, 2018, stating that UCan Universal had to turn business away because of the space taken up by the Stored APMs and that he would normally have delivered notice to InPost to leave.
- 2.1.6 Mr. Trejgo reiterated UCan Universal's request for removal of the Stored APMs to representatives of the Interim Receiver during other in-person meetings up to and

including the meeting on June 12, 2018 when the Interim Receiver provided Mr. Trejgo with the payments for rent and removal costs. At no time did any representatives of UCan Universal contact the Interim Receiver to indicate that they changed their position and would be willing to have the Stored APMs remain at the UCan Universal warehouse, nor did they indicate that UCan Universal had the space to store the other 136 APMs currently located at the various Retailers. UCan Universal did not ever provide the Interim Receiver with any proposals to store the APMs or any pricing for such storage even though UCan Universal was fully aware of the Interim Receiver's search for a location to store all of the APMs.

- 2.1.7 The Interim Receiver is also of the view that it is preferable for the APMs to be warehoused at a location controlled by a neutral third party, not a party involved in the ownership dispute. UCan Universal and UCan Post appear to be related entities based on their corporate profiles as they both list Tony Jasinski as a Director. The corporate profiles for UCan Universal and UCan Post, dated June 11, 2018, are attached hereto as **Appendices B and C** respectively.

Regarding the space increase due to the extra machines received.

One was brought in to the warehouse on November 14th, 2017 and the other units that sit in dock # 28 have been p/u and staged about August-October 2017.

Therefor the extra space has been utilized since November 2017. Billing back for the extra 500 sq ft for Jan and Feb is fair.

Regarding the increase in rates as of March 1st 2018, I recently have had to turn business away, I would have normally provided you notice to leave but I know you are still working things out. That being said, U Can shouldn't be losing out because of the internal issues of Inpost.

This is not the rate I should be charging and reflects what I believe to be fair given the circumstance at this time.

You are currently month to month and have paid until the end of this month. If you remove your inventory by then, I can reduce your charges proportionally for the space you utilize as of March 1st. Minimum space you can lease is 1,000 sq ft in increments of 500.
