**BANKRUPTCY ORDER**


And upon hearing the counsel for the Applicant Creditor;

And it appearing to the court that the following acts of bankruptcy have been committed:

a) Liquidation King Inc. has ceased to meet its liabilities generally as they become due.

1. IT IS ORDERED that the said Liquidation King Inc., of the City of Cambridge, in the Regional Municipality of Waterloo, in the Province of Ontario, and lately carrying on business in the City of Cambridge, in the Regional Municipality of Waterloo, in the Province of Ontario is hereby adjudged bankrupt and a Bankruptcy Order is hereby made against the said Liquidation King Inc.

2. IT IS FURTHER ORDERED that BDO Canada Limited of the City of Hamilton, in the Province of Ontario be and is hereby appointed Trustee of the estate of the said bankrupt.
3. IT IS FURTHER ORDERED that the said trustee give security in cash or by bond in accordance with subsection 16(1) of the *Bankruptcy and Insolvency Act*.
4. IT IS FURTHER ORDERED that the costs of the applicant shall be paid out of the estate of the bankrupt upon taxation thereof.
