ORDER
(Compelling Compliance and Return of Property)

THIS MOTION made by BDO Canada Limited in its capacity as the Court-appointed Receiver (the "Receiver") of all of the assets, undertakings and properties of Mars Freight Ltd., All Link Freight Services Ltd. and 11675443 Canada Inc. ("11675443") for an Order compelling certain parties to comply with the terms of the Receivership Order and return certain Property, was heard this day by way of judicial telephonic hearing in Toronto, Ontario.

ON READING the First Report of the Receiver dated April 7, 2020 (the "First Report") and on hearing the submissions of counsel for the Receiver, no one else appearing or served, as this matter was brought on an *ex parte* basis:

SERVICE

1. THIS COURT ORDERS that the time for service of the Notice of Motion and the Motion is hereby dispensed with, so that this motion is properly returnable today.

COMPLIANCE WITH THE RECEIVERSHIP ORDER AND RETURN OF PROPERTY

2. THIS COURT ORDERS AND DIRECTS that each of Skyland Carriers Inc. and Sukhvinder Dhadda shall comply with the Order granted by this Court on February 26, 2020 (the "Receivership Order"), including without limitation paragraphs 5, 6 and 7 therein, and forthwith provide to the Receiver the three Volvo 2020 VNL760 model series trucks with VIN numbers 4V4NC9EH1LN219108, 4V4NC9EHXLN219107 and 4V4NC9EH8LN219106.

3. THIS COURT ORDERS AND DIRECTIONS that Skyland Carriers Inc., Sukhvinder Dhadda, Mars Freight Ltd. and/or Mandeep Dhillon shall provide the Receiver with the bills of sale and proof of transfer of consideration with respect to the four Volvo 2015 VNL64T670 model series trucks with VIN numbers 4V4NC9EJ0FN188618, 4V4NC9EJ2FN188619, 4V4NC9EH5FN184321 and 4V4NC9EH7FN184322.

4. THIS COURT ORDERS AND DIRECTS that each of Sukhvinder Dhadda and Mandeep Dhillon shall comply with the Receivership Order in all respects, including without limitation paragraphs 5, 6 and 7 therein, and forthwith provide to the Receiver: (a) any Property (as defined in the Receivership Order) in their possession to the Receiver; (b) full disclosure of all of the Respondents' property, assets, books and records, including information with respect to any owned real property, actual location of 11675443's office, and information to access any such information where provided in electronic format; and (c) disclose to the Receiver the location where the funds from the collection of the Mars Receivables (as defined in the First Report) are located/deposited.

5. THIS COURT ORDERS that nothing herein shall be taken as limiting, narrowing or otherwise restricting the existing obligations of all persons, including but not limited to Sukhvinder Dhadda and Mandeep Dhillon, from complying with all terms of the Receivership Order.

GENERAL

6. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals,

regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.
