

## APPLICATION

1. Brake Pro, Ltd. (the "Applicant") makes application for:
  - (a) an Order dispensing with service on all creditors of the Applicant with the exception of those parties listed on the Notice of Application;
  - (b) leave, if required, to bring this Application on short notice;
  - (c) an Order under the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36 ("CCAA") in a form to be filed with the court; and
  - (d) such further and other relief as this Honourable Court may deem just.
  
2. **THE GROUNDS FOR THE APPLICATION ARE:**
  - (a) the Applicant is a manufacturer of brake friction material for the North American market;
  - (b) the Applicant has experienced poor operating results over the last two years, principally arising from increases in raw material costs, high production costs, and a rising Canadian dollar;
  - (c) the Applicant is in default in its obligations to its bank, Wachovia Capital Finance Corporation (Canada);
  - (d) the Applicant does not have sufficient cash to pay its liabilities in the ordinary course and is insolvent;
  - (e) the Applicant is a company to which the CCAA applies;
  - (f) the Applicant requires a stay of proceedings from its creditors in order that it may restructure, or alternatively, sell its assets for the benefit of its creditors;
  - (g) the provisions of the CCAA, as amended, and the equitable jurisdiction of this Court;

- (h) Rules 2.03, 3.02 and 14.05(2) of the Rules of Civil Procedure; and
- (i) such further and other grounds as counsel may advise and this Honourable Court may permit.
