UPON THE APPLICATION of Robert Kubke, a creditor, filed the 16th day of June 2011; AND UPON reading the Affidavit of Robert Kubke sworn the 10th day of June 2011, filed, and upon having seen the exhibits thereto; AND UPON reading the Affidavit of Service of Diandra Chipman sworn the 17th day of June 2011, filed, and upon having seen the exhibits thereto; AND UPON hearing counsel for the applicant, and it appearing to the Court that the debtor Bridgegate Mortgage Corporation has committed the following act of bankruptcy:

- (a) Bridgegate Mortgage Corporation has, within the six months immediately preceding the date of filing the within application, ceased to meet its liabilities generally as they become due.

IT IS ORDERED THAT:

1. The time for service of the Originating Application for a Bankruptcy Order and supporting affidavit is hereby abridged to the time actually given and service thereof is deemed good and sufficient in the manner set out in the Affidavit of Service filed herein.
2. The Court hereby orders that Bridgegate Mortgage Corporation, a corporation incorporated pursuant to the laws of the Province of Alberta and having a registered office at #300, 1333 – 8th Avenue S.W., Calgary, Alberta, be adjudged bankrupt and a bankruptcy order is hereby made against Bridgegate Mortgage Corporation.
3. Craig Fryzuk of BDO Canada Limited of Calgary, Alberta, be and is hereby appointed trustee of the estate of the bankrupt.
4. The Court further orders that the trustee give security in cash or by bond or suretyship without delay, in accordance with subsection 16(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3.
5. The costs of and incidental to this application and of this order be paid to the applicant out of the assets of the estate of the bankrupt forthwith after taxation thereof.
