

UPON the Application of the Applicants, Calgary Oil & Gas Syndicate Group Ltd., Calgary Oil and Gas Intercontinental Group (in its own capacity and in its capacity as general partner of T5 SC Oil and Gas Limited Partnership), Calgary Oil and Syndicate Partners Ltd., and Petroworld Energy Ltd. (collectively, the "**Applicants**"), to compel and direct the Respondent, Westbrick Energy Ltd. (the "**Respondent**"), to provide responses to undertakings and objections arising from the cross-examination of the Respondent's corporate representative, Maninder (Moe) Mangat,

conducted on April 9, 2021 (the “**Examination**”) in respect of his Affidavit sworn on April 8, 2021 (the “**Mangat Affidavit**”); **AND UPON** having read the Applicants’ Application for a stay extension and approval of a claims procedure, and the Respondent’s Cross-Application for an order directing the convening and conducting of a creditors’ meeting in the within proceedings, the Mangat Affidavit, and the transcript of the Examination; **AND UPON** having heard from counsel for the Applicants, counsel for the Respondent, and any other interested parties present;
