AND UPON READING the affidavits of Paul G. Goodman sworn July 5, 2011, and Carl Holm sworn July 12, 2011, and all other materials filed herein;

AND UPON HEARING Carl A. Holm, Q.C. on behalf of the applicant BDO Canada Limited and counsel for other parties appearing on the motion;

NOW UPON MOTION it is hereby ordered that:

Service

1. Service of the Application Documents upon any interested party is hereby dispensed with except for service on Canada Sailing Expeditions Inc., Caterpillar Financial Services Limited, Nova Scotia Business Inc., Growthworks Atlantic Venture Fund Limited, and Canada Revenue Agency.

Actions and Accounts

2. The actions of the Receiver, the accounts of the Receiver as set out in its Final Statement of Receipts and Disbursements, and the Receiver's Fees and the fees of its legal counsel including the final accounts of the Receiver and its legal counsel all as set out and referred to in the affidavit of Paul G. Goodman sworn July 5, 2011, on file herein be and are hereby ratified and approved.

CRA Property Charges

3. It is hereby declared that the property claim of Canada Revenue Agency constituting a charge on the assets of the Receivership and payable out of funds held by the Receiver is limited to the amount of \$35,376.73 (the "Property Claim").

Set Off

The Receiver is hereby authorized to set off against the amount payable to Canada 4. Revenue Agency on account of the Property Claim the amount of \$4,280.64 being Input Tax Credits in respect of HST which the Receiver is entitled to from the Canada Revenue Agency and the amount of Input Tax Credits in respect of the final accounts of the Receiver and its legal counsel Wickwire Holm estimated to be \$1,141.35.

Disbursements

- 5. The Receiver is authorized and directed to disburse the funds held in trust by it for the benefit of Receivership as follows:
 - to Canada Revenue Agency the amount of the Property Claim less the amount of a. offsets approved herein;
 - to the Receiver its final account in the amount of \$5,271.60; b.
 - to Wickwire Holm its final account in the amount of \$3,478.75; c.
 - the balance to Caterpillar Financial Services Limited. d.

Discharge

Except for its obligations to pay monies in the manner and to the persons as set out in 6. paragraph 5 hereof, the Receiver BDO Canada Limited is hereby discharged from its duties under the Receivership Order granted herein on November 20, 2009, and any

subsequent orders issued herein and its appointment is terminated.
