ORDER CLOSING CHAPTER 15
CASES

The Motion for Order Closing Chapter 15 Cases (the "Closing Motion") was brought by BDO Canada Limited, the court-appointed receiver (the "Receiver") and authorized foreign representative of Combat Sports Inc. and Combat Sports, Inc. (collectively, "Combat") in a proceeding (the "Canadian Proceeding") under Subsection 243(1) of Canada's Bankruptcy and Insolvency Act, R.S.C. 1985, c. B-3 (as amended) and Section 101 of Ontario's Courts of

1 Justice Act, R.S.O. 1990, c. C.43 (as amended), pending before the Superior Court of Justice
2 of Ontario (the "Canadian Court").

3 By the Closing Motion, the Receiver requested that this Court enter an order pursuant to
4 sections 350(a) and 1517(d) of the Bankruptcy Code closing these Chapter 15 cases.

6 The Court has considered and reviewed the Closing Motion and based on the foregoing,
7 and sufficient and proper notice of the Closing Motion and the relief requested therein having
8 been provided, and a certificate having been filed stating that no objections were filed, after due
9 deliberation and sufficient cause appearing therefor:

10 IT IS ORDERED:

11 1. The Motion is GRANTED.

12 2. The above-captioned Chapter 15 cases are hereby closed pursuant to section
13 350(a) and 1517(d) of the Bankruptcy Code, without prejudice to the right of the Receiver to
14 seek an order reopening the cases under section 350(b) of the Bankruptcy Code.

16 3. This Court shall retain jurisdiction with respect to the enforcement, amendment
17 or modification of this Order or requests for any additional relief in or related to these Chapter
18 15 cases.
