

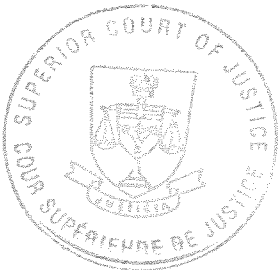

ORDER

THIS MOTION, made on short notice to all parties by the Applicant/Moving Party, Attorney General of Ontario, for a preservation order under *the Civil Remedies Act, 2001* ("*Civil Remedies Act*"), was heard this day at the court house located at 330 University Avenue, Toronto.

ON READING the Motion Record and Factum of the Attorney General, and on hearing submissions of counsel for the Attorney General,

1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.
2. **THIS COURT ORDERS** preservation, pursuant to section 4(1) of the *Civil Remedies Act*, of the payment made to Judith Hunking under the Agreement of Purchase and Sale, approved by the Commercial Court on August 26, 2016 and having closed on October 3, 2016, in particular the payment of \$150,000 made to Judith Hunking as consideration for the signing of a non-competition agreement with Revera Inc., until November 25, 2016, or the disposition of the interlocutory preservation motion, whichever is earlier.
3. **THIS COURT ORDERS** that Judith Hunking pay the amount of \$150,000 forthwith to her counsel, Mr. Daniel Naymark, and to be held in trust by her counsel until further order of this Court.
4. **THIS COURT ORDERS** that this matter return on November 25, 2016, at which time a motion for preservation of the \$150,000 pending determination of the forfeiture application will be heard (for approx. 2 hours), pursuant to the *Civil Remedies Act*.
