

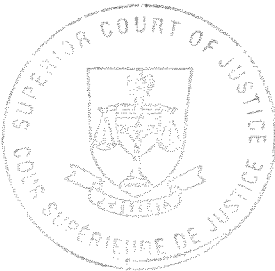

**THIS MOTION**, made on notice to all parties by the Applicant/Moving Party, Attorney General of Ontario, for a preservation order under *the Civil Remedies Act, 2001* ("*Civil Remedies Act*"), was heard this day at the court house located at 330 University Avenue, Toronto.

**ON READING** the Motion Record and Factum of the Attorney General, and on hearing submissions of counsel for the Attorney General,

1. **THIS COURT ORDERS** that the time for service of the Notice of Motion and the Motion is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.
  
2. **THIS COURT ORDERS** preservation, pursuant to section 4(1) of the *Civil Remedies Act* of the proceeds of sale of the business and assets of Emmanuel Village Residence Inc., (“EVR”), including the proceeds of sale of:
  - i. The systems;
  - ii. The pre-paid rents and expenses;
  - iii. The Assumed Contracts;
  - iv. The Warranties;
  - v. The Books and Records;
  - vi. The Transferred Information;
  - vii. The Inventories;
  - viii. The Personal property including the vehicle and all computer equipment and non-proprietary computer software Related to the Business;
  - ix. The Intellectual Property;
  - x. The Licences;
  - xi. All goodwill Related to the Business;
  - xii. All rights, causes of action or rights of set-off against third persons Related to the Business or relating to the Assets, including all rights and interests under or pursuant to all warranties, representations and guarantees, express, implied or otherwise, of or made by suppliers or others in connection with the Assets or otherwise Related to the

Business, to the extent that the forgoing are, by the terms thereof,  
assignable; and

xiii. Any other assets and undertaking of the Business.

pending final disposition of the forfeiture Application.

3. **THIS COURT ORDERS AND DECLARES** that, notwithstanding paragraph 2, this Order will only be in respect of the proceeds of sale of those assets, consistent with the terms of the sale approval and vesting Order of Justice Hainey, dated August 26, 2016, and subject to the Order dated September 26, 2016 directing certain distributions by the Receiver, and the Endorsement of Justice Newbould dated September 29, 2016, directing further distributions by the Receiver, and any subsequent Order of the Court directing the Receiver to make any future distribution from such proceeds.
