Vidabode as of the date hereof is indebted and liable to BW Strassburger Ltd. ("BWS") in the amount of Five Million Dollars (\$5,851,999). As part of the security for payment of the present and future debts and liabilities of Vidabode, BWS holds General Security Agreements ("GSA").

Events of default have occurred in payment of the indebtedness and pursuant to the GSA. BWS hereby appoints BDO Canada Limited ("BDO") as Receiver and Manager of the secured property and instructs BDO to take all necessary actions to seize, protect and realize on the secured property for the benefit of BWS.

It is understood the security does not include the real estate. Thus, BDO will act in connection to the general assets and contents. Vidabode is expected to cooperate in some occupancy of the premises. There may be further appointments necessary including court appointed Receivership and/or bankruptcy of Vidabode required to conclude all of the realizations.

BDO is authorized to delegate all or any part of it's duties as Receiver and Manager to such other agent or agents as may be selected by BDO. It is understood that BWS is available and able to assist with the Receivership tasks where requested.

**Costs**

We understand that your fees will be at normal hourly rates and invoiced throughout the administration. The BDO offices in Halifax and Kitchener will be working together in completing this assignment.


We understand that BDO Canada Limited is required to have independent legal counsel and as such agree to payment of those costs with the Receiver's/agent's costs. This will include independent counsel to review and vet the BWS security prior to the Receivership appointment being activated.

In the event that there are insufficient assets realized from the assets of Vidabode, we agree to pay your fees and expenses as Receiver and Manager and agent or any other subsequent appointments. We also agree to indemnify you and keep you indemnified hereafter against all liabilities, actions, proceedings, claims and demands, costs, damages and expenses which may be brought or made against you or which you may pay.


