After 60 days from the due date owners who have not paid their Association Fee for the current Use Year will be sent to a collection agency, and will be subject to additional interest charges at 30% per annum calculated monthly from date of original invoice.

Each person who becomes a New Owner after October 15th in any Use Year will be billed the Association fee for the upcoming Use Year at the time the Deed to the Interval is registered and will be due 30 days from the date of the invoice. Late fees will commence within 30 days of billing in increments as outlined above.
