**Remedy claimed or sought:**

1. Capitalized terms not otherwise defined herein, shall have the meaning ascribed to them in the Fourth Report of the Receiver, BDO Canada Limited ("**BDO**"), the court-appointed receiver and receiver and manger (the "**Receiver**"), of Safeguard Real Estate Investment Fund IV Limited Partnership and CEP LP Investment Corp. (collectively the "**Debtors**"), dated December 2, 2024 (the "**Fourth Report**") or the Confidential Supplement to the Fourth Report of the Receiver, dated December 2, 2024 (the "**Confidential Supplement to the Fourth Report**"), as the context requires.
2. An order, in substantially the form attached hereto as **Schedule "B"**:
  - (a) abridging the time for service of this application and deeming service good and sufficient and declaring that no other person is required to have been served with notice of this Application, if necessary;
  - (b) authorizing and approving the sale transaction in the CAKO APA between the Receiver and CAKO Holdings Ltd. ("**CAKO**"), as described in the Fourth Report and the Confidential Supplement to the Fourth Report;
  - (c) authorizing and directing the Receiver to take such steps and execute all such deeds, documents and instruments as may be reasonably necessary to consummate the CAKO APA;
  - (d) upon delivery of a Receiver's Closing Certificate, vesting all of the Debtors' right, title, and interest in and to the Purchased Assets (as that term is defined in the form of Order attached as Schedule "B" hereto) in CAKO (or its nominee), free from all claims and encumbrances, except permitted encumbrances; and
  - (e) granting leave to the Receiver to apply or reapply to this or any court or administrative body in any province of Canada for advice, assistance and directions as may be necessary to carry out the terms of the order sought.
3. An order, in substantially the form attached hereto as **Schedule "C"**:

  - (b) authorizing and approving the sale transaction in the TDT APA between the Receiver and TDT Real Estate Management & Holding Corp. ("**TDT**"), as described in the Fourth Report and the Confidential Supplement to the Fourth Report;

7. Such further and other relief as may be sought and this Honourable Court deems just and appropriate.

**Grounds for making this application:**

**Receivership Proceedings**

8. On December 4, 2020, pursuant to an application made by Connect First Credit Union Ltd. (“CFCU”) in respect of the Debtors, BDO was appointed as Receiver of the Debtors by virtue of an order of the Court of King’s Bench of Alberta (the “**Receivership Order**”).
9. The Receivership Order was amended on June 21, 2021.
10. The material assets of the Debtors are the thirty (30) separate titled office space units (the “**Units**”) and thirty (30) separate titled parking stalls (the “**Parking Stalls**”) located in the Building.

**Activities of the Receiver to Date**

11. Since its appointment, the Receiver has taken possession of the Property and taken such prudent steps, as have been necessary, to preserve the Property.
12. Since the Third Report, the Receiver’s activities include, among other things, as more expressly detailed in paragraphs 28 – 39 of the Fourth Report:
  - (a) closing of the Cascade APA;
  - (b) attending to filing tax appeals for the years 2023 and 2024;
  - (c) liaising with Avison Young in respect to the ongoing marketing and sales efforts, offer submissions and information requests as part of the Sale Process;
  - (d) completing a sale of Parking Stall #111 to New Sun pursuant to paragraph 3(k)(i) of the Receivership Order; and
  - (e) corresponding with various stakeholders of the estate.
13. The Receiver seeks approval and ratification of the actions, activities, recommendations and conduct of the Receiver, as set out and described in the Fourth Report.

**Accounts of the Receiver and its Counsel**

14. A summary of the Receiver’s accounts and those of its legal counsel are set out at paragraphs 53 - 54 of the Fourth Report.
15. The fees and expenses of the Receiver and those of its counsel were properly incurred, fair and reasonable, consistent with market rates for firms providing similar services on matters of similar complexity in Alberta and the work was properly delegated to the appropriate seniority level.

**Approving the 2024 APAs**

16. Pursuant to the terms of the Receivership Order, and in particular paragraphs 3(k) and 3(l), the Receiver is authorized to market the assets, undertakings, and properties of the Debtors (the “**Property**”) and sell the Property with approval of the Court.

17. The Receiver has engaged in various efforts to market and sell the Property, as are more particularly described in the Fourth Report.

#### *CAKO APA*

18. On October 15, 2024, the Receiver entered into the CAKO APA.
19. The Receiver reviewed this offer with CFCU, who has a first registered mortgage on the real property comprising part of the Purchased Assets (as defined in Schedule "B").
20. CFCU advised they were supportive of the proposed sale to CAKO.
21. The sale process and manner in which the offer for the Purchased Assets (as defined in Schedule "B") was received and approved was fair and just in the circumstances, with the interests of all stakeholders being considered.
22. The Receiver has made significant efforts to obtain the best possible price for the Purchased Assets (as defined in Schedule "B") and recommends the approval of the sale to CAKO pursuant to the CAKO APA.

#### *TDT APA*

23. On May 21, 2024, the Receiver entered into the TDT APA, as amended by the amending agreements entered into on July 4, 2024, August 6, 2024, and October 22, 2024.
24. The Receiver reviewed this offer with CFCU, who has a first registered mortgage on the real property comprising part of the Purchased Assets (as defined in Schedule "C").
25. CFCU advised they were supportive of the proposed sale to TDT.
26. The sale process and manner in which the offer for the Purchased Assets (as defined in Schedule "C") was received and approved was fair and just in the circumstances, with the interests of all stakeholders being considered.
27. The Receiver has made significant efforts to obtain the best possible price for the Purchased Assets (as defined in Schedule "C") and recommends the approval of the sale to TDT pursuant to the TDT APA.

#### *S&O APA*

28. On November 15, 2024, the Receiver entered into the S&O APA, a conditional offer with financing and due diligence conditions included therein to be met or otherwise waived on December 9, 2024.
29. The Receiver reviewed this offer with CFCU, who has a first registered mortgage on the real property comprising part of the Purchased Assets (as defined in Schedule "D").
30. CFCU advised they were supportive of the proposed sale to S&O.

31. The sale process and manner in which the offer for the Purchased Assets (as defined in Schedule "D") was received and approved was fair and just in the circumstances, with the interests of all stakeholders being considered.
32. The Receiver has made significant efforts to obtain the best possible price for the Purchased Assets (as defined in Schedule "D") and recommends the approval of the sale to S&O pursuant to the S&O APA.

**Sealing Order**

33. The Confidential Supplement to the Fourth Report contains commercially sensitive information, is confidential, and should be sealed until the expiry of three months from the date of the closing of any ultimate sale of the last of the Units and Parking Stalls comprising the Property. The terms set out in the proposed form of order attached as Schedule "F" are necessary to accomplish this.
34. The sealing order will also prevent the tainting of future sales for the remaining Units and Parking Stalls and is required should the CAKO APA, TDT APA and S&O APA fail to be completed.
35. The proposed sealing order is limited in that the Confidential Supplement to the Fourth Report would only remain sealed for a specified period of time. The public disclosure of the information contained in the Confidential Supplement to the Fourth Report, prior to the closing of the last sale for the Property, would cause serious and irreparable harm to the estate and its stakeholders. The sealing provision is a fair and reasonable means to address the harm of restricting public dissemination at this time.
36. The relief requested is just, appropriate, and in the best interests of the administration of the estate.
37. Such further and other grounds as counsel may advise and this Honourable Court may permit.

**IT IS HEREBY ORDERED AND DECLARED THAT:**

**SERVICE**

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this application and time for service of this application is abridged to that actually given.

**APPROVAL OF TRANSACTION**

2. The Transaction is hereby approved and execution of the Sale Agreement by the Receiver is hereby authorized and approved, with such minor amendments as the Receiver may deem necessary. The Receiver is hereby authorized and directed to take such additional steps and execute such additional documents as may be necessary or desirable for completion of the Transaction and conveyance of the Purchased Assets to the Purchaser (or its nominee).

**VESTING OF PROPERTY**

3. Upon delivery of a Receiver's certificate to the Purchaser (or its nominee) substantially in the form set out in **Schedule "A"** hereto (the "**Receiver's Closing Certificate**"), all of the Debtors' right, title and interest in and to the Purchased Assets listed in **Schedule "B"** hereto shall vest absolutely in the name of the Purchaser (or its nominee), but subject to the Permitted Encumbrances (hereinafter defined), free and clear of and from any and all caveats, security interests, hypothecs, pledges, mortgages, liens, trusts or deemed trusts, reservations of ownership, royalties, options, rights of pre-emption, privileges, interests, assignments, actions, judgements, executions, levies, taxes, writs of enforcement, charges, or other claims, whether contractual, statutory, financial, monetary or otherwise, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, "**Claims**") including, without limiting the generality of the foregoing:

  - (iii) transfer to the New Certificate of Title the existing instruments listed in Schedule “D”, to this Order, and to issue and register against the New Certificate of Title such new caveats, utility rights of ways, easements or other instruments as are listed in Schedule “D”; and
  - (iv) discharge and expunge the Encumbrances listed in Schedule “C” to this Order and discharge and expunge any Claims including Encumbrances (but excluding Permitted Encumbrances) which may be registered after the date of the Sale Agreement against the existing Certificate of Title to the Lands.
5. In order to effect the transfers and discharges described above, this Court directs each of the Governmental Authorities to take such steps as are necessary to give effect to the terms of this Order and the Sale Agreement. Presentment of this Order and the Receiver’s Closing Certificate shall be the sole and sufficient authority for the Governmental Authorities to make and register transfers of title or interest and cancel and discharge registrations against any of the Purchased Assets of any Claims including Encumbrances but excluding Permitted Encumbrances.
  6. No authorization, approval or other action by and no notice to or filing with any governmental authority or regulatory body exercising jurisdiction over the Purchased Assets is required for the due execution, delivery and performance by the Receiver of the Sale Agreement.
  7. Upon delivery of the Receiver’s Closing Certificate together with a certified copy of this Order, this Order shall be immediately registered by the Land Titles Registrar notwithstanding the requirements of section 191(1) of the *Land Titles Act*, RSA 2000, c.L-7 and notwithstanding that the appeal period in respect of this Order has not elapsed. The Land Titles Registrar is hereby directed to accept all Affidavits of Corporate Signing Authority submitted by the Receiver in its capacity as Receiver of the Debtors and not in its personal or corporate capacity.
  8. For the purposes of determining the nature and priority of Claims, net proceeds from sale of the Purchased Assets (to be held in an interest bearing trust account by the Receiver) shall stand in the place and stead of the Purchased Assets from and after delivery of the Receiver’s Closing Certificate and all Claims including Encumbrances (but excluding Permitted Encumbrances) shall

not attach to, encumber or otherwise form a charge, security interest, lien, or other Claim against the Purchased Assets and may be asserted against the net proceeds from sale of the Purchased Assets with the same priority as they had with respect to the Purchased Assets immediately prior to the sale, as if the Purchased Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale. Unless otherwise ordered (whether before or after the date of this Order), the Receiver shall not make any distributions to creditors of net proceeds from sale of the Purchased Assets without further order of this Court, provided however the Receiver may apply any part of such net proceeds to repay any amounts the Receiver has borrowed for which it has issued a Receiver's Certificate pursuant to the Receivership Order.

9. Except as expressly provided for in the Sale Agreement or by section 5 of the Alberta *Employment Standards Code*, the Purchaser (or its nominee) shall not, by completion of the Transaction, have liability of any kind whatsoever in respect of any Claims against the Debtors.

Upon completion of the Transaction, the Debtors and all persons who claim by, through or under the Debtors in respect of the Purchased Assets, and all persons or entities having any Claims of any kind whatsoever in respect of the Purchased Assets, save and except for persons entitled to the benefit of the Permitted Encumbrances, shall stand absolutely and forever barred, estopped and foreclosed from and permanently enjoined from pursuing, asserting or claiming any and all right, title, estate, interest, royalty, rental, equity of redemption or other Claim whatsoever in respect of or to the Purchased Assets, and to the extent that any such persons or entities remain in the possession or control of any of the Purchased Assets, or any artifacts, certificates, instruments or other indicia of title representing or evidencing any right, title, estate, or interest in and to the Purchased Assets, they shall forthwith deliver possession thereof to the Purchaser (or its nominee).

12. Immediately upon closing of the Transaction, holders of Permitted Encumbrances shall have no claim whatsoever against the Receiver.
13. The Receiver is directed to file with the Court a copy of the Receiver's Closing Certificate forthwith after delivery thereof to the Purchaser (or its nominee).

#### **MISCELLANEOUS MATTERS**

14. Notwithstanding:

- (b) the pendency of any applications for a bankruptcy order now or hereafter issued pursuant to the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c.B-3, as amended (the "BIA"), in respect of the Debtors, and any bankruptcy order issued pursuant to any such applications;
- (c) any assignment in bankruptcy made in respect of the Debtors; and
- (d) the provisions of any federal or provincial statute:

the vesting of the Purchased Assets in the Purchaser (or its nominee) pursuant to this Order shall be binding on any trustee in bankruptcy that may be appointed in respect of the Debtors and shall not be void or voidable by creditors of the Debtors, nor shall it constitute nor be deemed to be a transfer at undervalue, settlement, fraudulent preference, assignment, fraudulent conveyance, or other reviewable transaction under the BIA or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

- 15. The Receiver, the Purchaser (or its nominee) and any other interested party, shall be at liberty to apply for further advice, assistance and direction as may be necessary in order to give full force and effect to the terms of this Order and to assist and aid the parties in closing the Transaction.
- 16. Service of this Order shall be deemed good and sufficient by:
  - (a) Serving the same on:
    - (i) the persons listed on the service list created in these proceedings;
    - (ii) any other person served with notice of the application for this Order;
    - (iii) any other parties attending or represented at the application for this Order;
    - (iv) the Purchaser or the Purchaser's solicitors; and
  - (b) posting a copy of this Order on the Receiver's website at <https://www.bdo.ca/en-ca/extranets/safeguardiv/>, for no less than six months from the date of this Order;

and service on any other person is hereby dispensed with.
