REMEDY CLAIMED OR SOUGHT:

- 1. The applicant, OAN Resources Ltd. ("**OAN**"), seeks an Order substantially in the form attached hereto as **Schedule** "A", which includes the following relief:
 - (a) Abridging the time for service of this Application and the supporting materials, as necessary, and deeming service thereof to be good and sufficient;
 - (b) Extending the stay of proceedings, pursuant to Section 50.4(9) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985 c.B-3 (the "*BIA*"), for a further period of 45 days to August 28, 2019;
 - (c) Declaring that Crimson Oil & Gas Ltd., Highwood Oil Company Ltd. and David Hudgeon are critical suppliers to OAN (the "**Critical Suppliers**"), and that all payments made by OAN to the Critical Suppliers subsequent to the date of the NOI (as defined below) are hereby ratified and approved, and OAN is hereby authorized to continue making payments to the Critical Suppliers provided all such payments are first approved by the Proposal Trustee; and
 - (d) Granting such further and other relief as counsel may advise and this Honourable Court deems appropriate in the circumstances.

GROUNDS FOR MAKING THIS APPLICATION:

The Extension of the Stay of Proceedings

- 2. OAN is an insolvent corporation, which filed a Notice of Intention to make a Proposal on June 14, 2019 (the "NOI").
- 3. OAN requires an extension of the stay of proceedings in order to continue with its financial restructuring with a view to ultimately making a proposal to its creditors.
- 4. The extension of the stay of proceedings is appropriate because:
 - (a) OAN has acted, and is acting, in good faith and with due diligence;
 - (b) OAN anticipates it will be able to make a viable proposal if the extension it is applying for is granted; and
 - (c) no creditor will materially be prejudiced if the extension OAN is applying for is granted.

5. The Proposal Trustee supports an extension of the stay of proceedings.

Critical Suppliers

6. Crimson Oil & Gas Ltd., Highwood Oil Company Ltd. and David Hudgeon are suppliers to OAN for services critical to the continued business of OAN. Failure by OAN to continue to honour its contractual obligations to the Critical Suppliers will cause disruption of OAN's business and future revenue streams, and threaten a successful restructuring.
