## SUPPLEMENT TO THE THIRD REPORT OF BDO CANADA LIMITED, IN ITS CAPACITY AS RECEIVER

#### I. INTRODUCTION

1. Pursuant to the Order of the Honourable Madam Justice Conway of the Ontario Superior Court of Justice (Commercial List) (the "**Court**") dated November 8, 2021 (the "**Receivership Order**"), BDO Canada Limited ("**BDO**") was appointed as receiver (in such capacity, the "**Receiver**") over Altmore Mortgage Investment Corporation ("**AMIC**"), Altmore Capital Inc., Independent Mortgage Advisors Inc. and Ian Ross McSevney ("**McSevney**") pursuant to section 248(1) of the *Business Corporations Act*, R.S.O. 1990, c. B.16, as amended and section 101 of the *Courts of Justice Act*, R.S.O. 1990, c. C.43, as amended. 2. This Report (the "**Supplementary Report**") is supplementary to, and should be read in conjunction with, the Third Report of the Receiver dated January 26, 2022 (the "**Third Report**").

#### II. PURPOSE OF SUPPLEMENTARY REPORT

#### A. Purpose of Supplementary Report

3. This Supplementary Report is filed to provide this Honourable Court with an update on Mr. McSevney's ongoing lack of compliance with the Receivership Order since the date of the Third Report. In particular, the Receiver advises as follows:

- Mr. McSevney failed to disclose the existence of two bank accounts with Equitable Bank; and
- (b) Mr. McSevney has failed to provide any documents or information to the Receiver.

4. In addition to the above, the Official Receiver (the "**OR**") has advised that Mr.

McSevney has not completed his examinations.

### B. Orders Sought

5. The Receiver files this Supplementary Report in support of its motion for, among other things, Orders:

- (a) Declaring that McSevney is in contempt of the Receivership Order;
- (b) Directing McSevney to pay the Receiver's costs of this Motion on a full indemnity basis;
- (c) If a finding of contempt is made, scheduling a hearing to determine the appropriate penalty; and
- (d) Such further relief as this Court deems appropriate.

#### **III. TERMS OF REFERENCE**

6. In preparing this Supplementary Report and making the comments herein the Receiver has, where applicable, relied upon information prepared or provided by third-party sources (collectively, the "Information"). Certain of the information contained in this Supplementary Report may refer to, or is based on, the Information. As the Information has been provided by third parties or has been obtained from documents filed with the Court in this matter, the Receiver has relied on the Information and, to the extent possible, has reviewed the Information for reasonableness. However, the Receiver has neither audited nor otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Generally Accepted Assurance Standards pursuant to the Canadian Institute of Chartered Accountants Handbook and accordingly, the Receiver expresses no opinion or other form of assurance in respect of the Information.

7. Capitalized terms are as defined in the Third Report unless otherwise defined herein.

### IV. CONTINUING NON-COMPLIANCE

#### A. Undisclosed Bank Accounts

8. Mr. McSevney has failed to disclose all of his bank accounts to the Receiver/Trustee, in breach of the Receivership Order and his duties as a bankrupt in accordance with the BIA.

9. Specifically, on January 10, 2022, BDO, in its capacity as Trustee of the McSevney bankruptcy estate, was advised by Tangerine Bank that mortgage payments in respect of an investment property co-owned by McSevney were being drawn from an account at Equitable Bank ("EQB"). A copy of a void cheque was provided to the Trustee and is attached hereto as Appendix "A".

10. The Trustee immediately wrote to EQB requesting details and freezing of any and all accounts that McSevney has at EQB. The Trustee subsequently made a similar request of EQB in respect of the other corporate debtors in these proceedings and was advised that only McSevney had accounts at EQB.

11. EQB provided bank statements in respect of McSevney's two bank accounts to the Trustee. These statements indicate that McSevney began banking at EQB in September of 2021. Copies of each account statement are attached hereto as **Appendices "B" and "C"**, respectively.

#### **B.** Failure to Disclose Information or Documents

12. Since the date of the Third Report, Mr. McSevney has failed to disclose any information or documents to the Receiver.

13. On March 29, 2022, by letter from its counsel, the Receiver renewed its request that Mr. McSevney deliver copies of all documents, correspondence and other records related to Altmore, its business and its affiliates. Attached as **Appendix "D**" hereto is a copy of the email to McSevney dated March 29, 2022 from Receiver's counsel, Gregory Azeff of Miller Thomson LLP. The Receiver has not yet received any response from McSevney.

#### C. Incomplete OR Examination

14. In mid-January the OR of the Office of the Superintendent in Bankruptcy notified the Trustee that two examinations had been scheduled with McSevney in respect of his personal bankruptcy and the bankruptcy of AMIC:

 January 27, 2022, 10:00 AM: Original scheduled date for examination of McSevney re: his bankruptcy; and (b) January 31, 2022, 10:00 AM: Original examination of McSevney as officer of AMIC.

15. The OR advised the Trustee that McSevney attended the first examination which lasted approximately 3 hours and was adjourned to be reconvened at 10:00 AM on Monday January 31, 2022. McSevney did attend the reconvened examination.

16. The original January 31<sup>st</sup> examination was then rescheduled to 10:00 AM on February 17, 2022. The OR advised that McSevney cancelled due to illness and indicated to the OR that he would contact him when he was feeling better to set a new date for the examination. The OR has advised the Trustee that McSevney has not arranged a new date.

## V. CONCLUSION

17. The Receiver has prepared this Supplementary Report in support of the relief sought in its Notice of Motion returnable February 1, 2022, including in particular, an Order:

- (a) Declaring that McSevney is in contempt of the Receivership Order;
- (b) Directing McSevney to pay the Receiver's costs of this Motion on a full indemnity basis;
- (c) If a finding of contempt is made, scheduling a hearing to determine the appropriate penalty; and
- (d) Such further direction as the Court considers appropriate.


