### REMEDY CLAIMED OR SOUGHT:

- 1. The applicant, OAN Resources Ltd. ("OAN"), seeks an Order substantially in the form attached hereto as **Schedule** "A", which includes the following relief:
  - (a) Abridging the time for service of this Application and the supporting materials, as necessary, and deeming service thereof to be good and sufficient;
  - (b) Extending the period for OAN to file a proposal (the "**Proposal**"), pursuant to Section 50.4(9) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985 c.B-3 (the "*BIA*"), for a further period of 45 days from August 28, 2019 to October 12, 2019;
  - (c) Sealing the Confidential Supplement (the "Confidential Supplement") to the Second Report of Hardie & Kelly Inc. in its capacity as proposal trustee (the "Proposal Trustee"); and
  - (d) Granting such further and other relief as counsel may advise and this Honourable Court deems appropriate in the circumstances.

#### GROUNDS FOR MAKING THIS APPLICATION:

# Extension to File Proposal

- 2. OAN is an insolvent corporation, which filed a Notice of Intention to make a Proposal on June 14, 2019 (the "NOI").
- 3. On July 8, 2019, OAN applied for and obtained a 45-day extension (the "Initial Extension") of the period for the filing of a Proposal under the *BIA*. The current stay of proceedings will expire on August 28, 2019.
- 4. Since the Initial Extension was granted, OAN has continued to work diligently and in good faith, including with its professional advisors, with the Proposal Trustee, and with various debentureholders ("Debentureholders"), which are its primary secured creditors.
- 5. However, OAN's financial restructuring efforts, consultations and analysis are continuing, and OAN requires additional time to determine the most appropriate structure for a viable Proposal.
- 6. A second extension of the period for the filing of a Proposal is therefore appropriate since:
  - (a) OAN has acted, and is acting, in good faith and with due diligence;
  - (b) OAN anticipates it will likely be able to make a viable Proposal if the second extension it is applying for is granted; and

- (c) no creditor will materially be prejudiced if the extension OAN is applying for is granted.
- 7. The Proposal Trustee supports a second extension of the period for the filing of a Proposal.
- 8. If a second extension is not granted, and OAN is deemed to have a made an assignment into bankruptcy pursuant to Section 50.4(8) of the *BIA*, OAN does not expect there will be any recoveries for unsecured creditors.

# Sealing Order

- 9. The Confidential Supplement to the Proposal Trustee's Second Report, to be filed in support of the relief sought by OAN in this Application, contains commercially sensitive information of OAN. If this information was disseminated, OAN's ability to financially restructure and make a viable Proposal would be placed in serious risk.
- 10. The sealing order sought for the Confidential Supplement is the least restrictive and prejudicial alternative to preventing the risks to OAN's financial restructuring and ability to make a viable Proposal.

#### **SERVICE**

1.
