THE APPLICATION of BDO Canada Limited in its capacity as Court-appointed Receiver and Manager(the "Receiver") of the assets, undertakings and properties of Vernon Recreational Products (VRP) Sales and Service Ltd. ("VRP") and 1390951 B.C. Ltd. (together with VRP, the "Debtors"), coming on for hearing at Vancouver, British Columbia, on the 17<sup>th</sup> day of September, 2024 AND ON HEARING Jordan Schultz, counsel for the Receiver, and those other counsel listed on Schedule "A" hereto, AND UPON READING the material filed, including the First Report of the Receiver.

THIS COURT ORDERS AND DECLARES THAT:

1. The Receivership Order made as of July 18, 2024 is hereby amended to authorize the Receiver to assign the Debtors into bankruptcy by adding the following as paragraph 2(t) thereto:

"without limiting paragraph 2(q) hereof, take such steps and execute, issue and endorse such documents as may be necessary or desirable to cause the Debtors, or any of them,

to make an assignment of all their property for the general benefit of their creditors pursuant to Section 49 of the BIA".

- 2. Upon the Receiver assigning the Debtors into bankruptcy, the Receiver may make an interim distribution to the Royal Bank of Canada ("RBC") in an amount up to \$8,000,000, provided that the Receiver shall at all times retain sufficient funds to pay any claims which rank in priority to RBC's claim.
- 3. Endorsement of this order by counsel appearing on this application, other than counsel to the Receiver, is hereby dispensed with.
