In the Claims Portal, you will be asked by BDO, or "the Trustee", to submit and upload Personal Information. If you do not agree with any terms of this Privacy Statement or BDO's Privacy Policy, please do not use the Claims Portal or submit any personal information to us.

Privacy Statement

It is important to us that we collect, use or disclose your personal information where we have your consent to do so. When you enter the Claims Portal, you will be asked to electronically indicate your consent to the Trustee's collection and use of the personal information that you submit. You will not be permitted to use the Claims Portal without having consented to the Trustee's use of the personal information that will be uploaded. By uploading any personal information to the Claims Portal, you are providing your consent to the Trustee's collection and use of all personal information that you submit.

Personal Information Collected

Personal Information is information about an identifiable individual. The Trustee will collect Personal Information from you when you voluntarily provide it through the Claims Portal, or when you provide it through other means, ie. through e-mail, telephone, mail, or other correspondence.

The Personal Information which will be collected may include:

- Contact and identification information, such as your name, address, telephone number, and e-mail address, which will be used to communicate with you about your potential Claim;
- Your government-issued photo identification, in order to verify your identity and comply with relevant or applicable reporting obligations; and
- Any other Personal Information that you choose to submit to us.

Purpose

The personal information collected by the Trustee is being collected to:

- allow the Trustee to carry out its review and verify Proof of Claim forms,
- protect against error and fraud;
- enable the Trustee to comply with applicable law or regulatory requirements; and
- any other reasonable purpose to which you consent.

Use

The information collected is limited to information that is necessary for the Trustee to perform its functions and carry out its duties. Your personal information will <u>not</u> be used for other purposes, such as advertising or marketing, and will not be disclosed to third parties for purposes unrelated to the administration of the Claims review, except where otherwise required by law.

Disclosure outside of BDO

From time to time, the Trustee may utilize the services of third parties, including lawyers, consultants, financial institutions, employees, contractors, IT professionals, and other parties who provide services to us or on our behalf, and these third parties may have access to your Personal Information by virtue of their assistance with the Claims Review

In addition, personal information may be disclosed:

- as permitted or required by applicable law or regulatory requirements;
- to comply with valid legal processes such as Court orders or reporting obligations to the Court;
- as part of BDO's regular reporting activities;
- where the personal information is publicly available;

International Transfer

In order to provide services to you via this portal and fulfil the Purpose we may need to transfer your personal information to third parties located outside of Canada to countries that may not provide a level of protection of personal information that may be regarded as equivalent to that afforded under Canadian data protection legislation. Whenever your personal information is transferred internationally, we will take appropriate steps to ensure its security and confidentiality in accordance with applicable data protection law.

Security and Retention

We maintain one or more databases to store your Personal Information and we retain your Personal Information as reasonably required to carry out the Claims process, protect against error and fraud, and comply with our legal and regulatory obligations. We may retain your Personal Information following the completion of the Claims Process where reasonably necessary to comply with any regulatory retention obligations.

It is important that the information you provide to us is both accurate and current.
