- 1. On December 2, 2022, BDO Canada Limited was appointed Receiver (the "Receiver") and became a Receiver under section 243(1) of the *Bankruptcy and Insolvency Act* of the property of MGT Management Inc. and MGT Aggregate Products Inc. (collectively, the "Debtor").
- 2. The undersigned became the Receiver by virtue of being appointed by the Court of Queen's Bench of Alberta pursuant to a Consent Receivership Order (the "Receivership Order"), granted by the Honourable Justice Hollins, dated December 2, 2022. - 3. The Debtor operated a limestone quarry in Clearwater, AB. Operations ceased following the Receiver's appointment. Due to a lack of insurance, which had lapsed prior to its appointment, the Receiver elected not to take possession of the quarry. The Receiver has coordinated recovery of certain equipment from the quarry which has been transported to a secure facility.
- 4. The intended plan of action of the Receiver is to realize on the Debtor's assets. The Receiver is presently in communication with various stakeholders relative to a potential turnkey sale of the business contingent on the Receiver's ability to source replacement insurance coverage and obtaining agreements from various parties.
