## **AFFIDAVIT OF WES SIEMENS** Sworn on March 26, 2024

I, WES SIEMENS, of the City of Calgary, in the Province of Alberta, MAKE OATH AND SAY AS FOLLOWS:

- 1. I am the President and Chief Executive Office of Kaden Energy Ltd. ("Kaden" or the "Applicant") and, as such, I have personal knowledge of the matters deposed to herein, except where stated to be based upon information and belief, and whereso stated, I believe such facts and matters to be true.
- 2. I am swearing this Affidavit in support of an Application by Kaden for the following relief:
  - extending the period of time within which Kaden is required to file a proposal to its creditors, under section 50.4 of the Bankruptcy and Insolvency Act, RSC 1985, c. B-3 (the "BIA") and the corresponding stay of proceedings provided for in section 69 of the BIA, until and including May 17, 2024;

- b. granting an administration charge (the "Administration Charge") in favour of counsel for Kaden, BDO Canada Limited (the "Proposal Trustee") and counsel for the Proposal Trustee in an aggregate amount of \$250,000.00;
- c. approving the payment of certain amounts for critical suppliers and vendors (collectively, the "Critical Suppliers") for services and work provided prior to the filing of the NOI;
- d. granting the Kaden Directors a charge (the "Directors' Charge") over the assets of Kaden, which shall not exceed \$100,000.00 to indemnify Kaden's Directors for liabilities that may be incurred after the commencement of these proceedings; and
- e. granting an order approving the Applicant's proposed claims process (the "Claims Procedure") to determine the quantum and classification of claims of Kaden's creditors.

## Summary of Activities since Filing the NOI

- 3. Kaden is a private, junior oil and gas company focused on acquiring and developing light tight oil in the Cardium Formation in northwest Alberta.
- 4. Kaden is an Alberta corporation incorporated pursuant to the laws of the Province of Alberta. Attached hereto and marked as Exhibit "A" is a Government of Alberta Corporate Search of "Kaden Energy Ltd."
- 5. On March 6, 2024, Kaden filed a Notice of Intention to Make a Proposal ("**NOI**") pursuant to the *BIA*.
- 6. Since the March 6, 2024 filing, Kaden has been in discussions with a potential lender to secure financing. Kaden is working with the Proposal Trustee and its counsel to prepare a proposal to its creditors. It is Kaden's intention to obtain financing to contribute to the Proposal to Kaden's creditors.
- 7. Since the filing of the NOI, Kaden has maintained its operations in the normal course and has remained cash-flow positive. Further Kaden has refrained from making payments of any pre-filing indebtedness since the filing of the NOI, except for certain

critical suppliers, royalty payments, and Crown payments as described in more detail below.

- In May 2024, revenues are anticipated to be impacted negatively due to a planned four week pipeline and gas facility outage by Pembina Pipeline Corporation, as well as the spring break-up.
- Currently, Kaden has anticipated reported production revenue of \$1,300,000 for March 2024. Other than the May shut down, Kaden anticipates remaining cash-flow positive throughout the proceedings.
- 10. Kaden anticipates that by June 2024 or July 2024 it will return to normal production.
- 11. Currently, Kaden has debts in the amount of approximately \$12,000,000. The creditors of Kaden are largely made of up trade creditors and for unpaid royalty amounts owing to Kaden Royalty Corp. and Arc Resources Ltd.
- 12. Attached hereto and marked as **Exhibit "B"** is a Alberta Personal Property Registry search for Kaden.
- 13. The Proposal Trustee has reviewed and provided input on Kaden's March 15, 2024 cash-flow forecast (the "Cash-Flow Forecast").
- 14. Attached hereto and marked as **Exhibit "C"** is a copy of the Cash-Flow Forecast and Report on Cash-Flow Statement.

### Administrative Charge

- 15. There are a number of financial and operating issues for which Kaden will require the expertise of the Proposal Trustee during the NOI proceedings (the "**Proceedings**").
- 16. Kaden's counsel, the Proposal Trustee, and its counsel are essential to the success of the Proceedings.
- 17. Based on the Cash-Flow Forecast, the anticipated professional fees over the reporting period for the Proposal Trustee, its counsel, and Kaden's counsel will be set out in the Cash-Flow Forecast appended to the first report of the Proposal Trustee. Kaden

therefore seeks a first ranking charge for the Administration Charge against all of its assets, property, and undertaking in the amount of \$250,000.00 to secure the fees and disbursements incurred in connection with services rendered to Kaden both before and after the commencement of the Proceedings.

18. The amount of the proposed Administration Charge was reached in consultation with the Proposal Trustee, and I believe is reasonable in the circumstances.

### **Extension of NOI and Stay Period**

- 19. Since the filing of the NOI, Kaden has been diligently pursuing activities aimed at the presentation of a proposal. In particular, Kaden has diligently:
  - a. provided the Proposal Trustee with access to Kaden's premises, property, and books and records;
  - b. working with the Proposal Trustee and counsel to prepare the Cash-Flow Forecast and to identify issues with respect to the financial condition of Kaden and the status of its creditors;
  - c. engaging in discussions with key creditors and a proposed lender for financing of Kaden's operations and the Proposal; and
  - responding to inquiries from various creditors regarding the status of the NOI proceedings.
- 20. I am advised by Catrina Webster of MLT Aikins LLP, Kaden's legal counsel, that the period within which Kaden has to file a proposal will expire on April 5, 2024 and that if the NOI is not extended, then Kaden will be deemed on April 6, 2024 to have made a voluntary assignment for the benefit of its creditors pursuant to section 50.4(8) of the *BIA*. Kaden is seeking an extension of 45 days from April 5, 2024 to May 20, 2024.
- 21. In the circumstances, I do verily believe that Kaden requires an extension of time to file a proposal to its creditors and that a proposal will be likely with the benefit of an extension.

#### **Critical Service Providers and Suppliers**

- 22. Kaden intends to make payments for certain goods and services supplied to Kaden for pre and post filing expenses and obligations which are key to its ongoing business operations. If these payments are not paid, there will be substantial disruption to Kaden's business and operations that could have a significant negative impact on its ability to generate revenue as contemplated by the Cash Flow Forecast.
- 23. Kaden is seeking authorization to pay all reasonable and necessary expenses incurred by Kaden in carrying on its business in the ordinary course and to pay certain expenses, whether incurred prior to or after the filing of the NOI, including, but not limited to, the following:
  - a. outstanding and future wages, salaries, compensation, employee benefits, contractor wages, director fees and expenses,
  - b. critical trade payables and suppliers, including, but not limited to, the following groups of entities:
    - i. contract operators that operate the production assets of Kaden West Rock, Len Elliott Consulting Ltd., and Jafco Production Services Ltd.; and
    - ii. critical suppliers and service providers who provide ongoing critical services or supplies, where there are limited available other service providers to replace those services and suppliers at the same cost and/or are required to continue to meet regulatory requirements for the continued operation of the assets. These suppliers and service providers, include, by way of example, the following entities: Xcel Automation Ltd., TNT Engineering Ltd., Expera Information Technology Inc., Cantango Commodity Marketing Inc., Direct Pressure, Carnwood Wireline Service Ltd., Caron Measurement & Controls Ltd., Full Force Ventures, Next Compression Corp., Pasco Energy Services Inc., Petro-Canada Lubricants Inc., I3 Energy Canada Ltd., Pandell Technology Corporation, Dynamic Energy Group Inc., Nortech Advanced NDT

Ltd., Wild Rows Pump & Compression Ltd., AGAT Laboratories, Baker Hughes Canada Company, Razorback Waste, We An-ser Communications Group, and Shock Trauma Air Rescue Surface, Pembina Gas Services, and Secure Energy Services.

(collectively, the "Critical Suppliers")

- 24. The Critical Suppliers payments include amounts for service providers and suppliers who perform or provide the following types of critical services and supplies for Kaden: equipment rentals, gas processing, trucking, processing, and handling of production, operations supervision, maintenance, chemical and lubricant supplies, safety, engineering support, compliance, production engineering, commodity marketing, IT services, software maintenance, and network safety.
- 25. These anticipated payments relate to contract operators and suppliers and other essential parties necessary to maintain the ongoing operations of Kaden including maintaining its current level of cash flow. Without these service providers providing these services and supplies to Kaden, it would be unable to operate its assets at the same level and for the same operating costs (as estimated in the Cash Flow Forecast) and thus maintain its estimated cash flow during the insolvency proceedings.
- 26. If these contractors and suppliers are not paid for certain limited pre-filing amounts incurred the significant concern is that they will seek other options, refuse to provide supplies or services where there is no agreement in place for such services, and/or will refuse to operate or service the Kaden assets.
- 27. Kaden would only pay pre-filing amounts for current Critical Suppliers that fall into the categories set out above and after first obtaining approval for such payments from the Proposal Trustee. We anticipate paying these amounts following the Court's approval and the approval of the Proposal Trustee. The payment of the foregoing amounts will slightly negatively impact the current cash flow forecast of Kaden but Kaden will continue to have sufficient available cash to continue to funds its operating costs and its restructuring costs during the Proceedings.

- 28. Kaden requires the commitment and support of its employees, contractors and the continued supply of goods and services from its key vendors, critical trade suppliers, and service providers during the Proceedings. The ability for Kaden to make the foregoing payments is necessary to maintain stability and for the continued and uninterrupted operation of Kaden's business during the Proceedings and in order to allow Kaden to advance its restructuring efforts for the benefit of all of its stakeholders.
- 29. In addition to the payment of Critical Suppliers, Kaden intends to continue to make payments to the Alberta Department of Energy for ongoing Crown royalties. While all amounts currently owing to the Alberta Department of Energy have been paid, Kaden anticipates providing payment for Crown Royalty Payments for December production at the end of March 2024 due to timing of invoicing for Crown royalties. This will keep Kaden's obligations to the Crown under its royalty agreements in good standing.
- 30. Similarly, Kaden intends to continue payments to the Alberta Department of Energy for annual Crown lease rental dues including a recent post NOI filing payment of \$3,541.10 related to a January crown mineral lease payment.
- 31. Respecting the unpaid royalty amounts owing to Kaden Royalty Corp. ("KRC") and Arc Resources Ltd. ("Arc"), Kaden proposes to continue making those payments as they become due in the ordinary course, including for the amounts incurred for the month just prior to filing the NOI. The royalty agreements contain certain language which may require that those funds be held in trust and Kaden has determined that it would be the most efficient to simply pay these amounts as they become due after the filing date of the NOI (but represent royalty payments incurred in months arising prior to the NOI filing).
- 32. Currently, Kaden owes KRC \$329,661.48 for royalties incurred in August 2023 to December 2023 and \$47,665.04 for royalties incurred in January 2024. Kaden is proposing to pay KRC for the royalties arising from January 2024 as it would pay these in the normal course from its March revenues received on or about March 25, 2024.
- 33. In addition, Kaden owes Arc \$27,287.41 for royalties incurred in September 2023 to December 2023 and \$5,792.26 for royalties incurred in January 2024. Kaden is

proposing to also pay Arc the amounts for January 2024 that would normally be payable from its March revenue.

- 34. The payment of these amounts would allow Kaden to avoid diverting resources to a determination of whether these payments constitute a trust claim which has been alleged by KRC and instead could just keep the payments to its royalty holders current post-filing pursuant to the terms of the agreements between the parties (amounts from unpaid months in 2023 would not be paid by Kaden at this time).
- 35. Kaden also has agreements in place with Tourmaline Oil Corp. ("**Tourmaline**") and Secure Energy Services to net out or rights to set-off invoices for various operations between Kaden and those entities. There are not currently any amounts owed to Tourmaline and Secure (as a result of Secure exercising its right of set-off against certain production of Kaden) and Kaden proposes to continue with those agreements in the normal course on a go forward basis.
- 36. Finally, Kaden anticipates making continued payments to the Canada Revenue Agency for GST in order to avoid the creation of any priority claims.

### **Directors' Charge**

- 37. To ensure that Kaden's operations and restructuring efforts continue, all in order to maximize value for Kaden's creditors, Kaden requires the continued participation of its directors and officers.
- 38. Kaden's directors and officers have specialized expertise and relationships with Kaden's suppliers, employees, and other stakeholders that cannot be replicated or replaced.
- 39. There is a risk to Kaden's directors and officers of incurring personal liability in the contact of the NOI proceedings. Due to the potentially significant personal exposure going forward, I believe that the Directors' Charge is appropriate in the circumstances. Kaden's directors have expressed the need for certainty with respect to potential personal liability if they continue in their current capacities.
- 40. I am advised by Kaden's counsel and do verily believe:

- a. the Directors' Charge is common in restructuring proceedings and is appropriate in the circumstances;
- b. the benefits of the proposed Directors' Charge will be available only to the extent that Kaden's directors and officers do not have coverage under such insurance policies or where such coverage is insufficient to pay the amounts indemnified; and
- c. the proposed value of the Directors' Charge is directly related to the statutory obligations for which the directors and officers may become liable if Kaden fails to meet those obligations. However, based on the current Cash-Flow Forecast it is expected that all of those amounts will be paid in the ordinary course and it is unlikely that the Directors' Charge will be relied upon.

#### **Claims Process**

- 41. In order to formulate a proposal that is tailored to the actual quantum of creditors claims, conduct voting on Kaden's Proposal, and to be able to make distributions thereunder, it is necessary to determine the quantum and classification of the claims being asserted against Kaden by its creditors.
- 42. The Applicant has, with the participation of the Proposal Trustee, developed a Claims Procedure for this purpose to ensure that the assessment of claims is done in the most efficient and expeditious manner possible.
- 43. The key terms of the proposed Claims Procedure include:
  - a. a Claims Package (as defined in the Claims Procedure) will be issued by the Proposal Trustee to each of the Known Claimants;
  - b. the Claims Procedure sets a Claims Bar Date of 10 days after receipt of the Claims Package for Unknown Claimants;
  - c. if a Known Claimant disagrees with the amount contained in the claim materials issued by the Proposal Trustee, a Claimant may deliver a Notice of Dispute to the Applicant, care of the Proposal Trustee, by no later than the Claims Bar Date (which is 14 days after receipt of the Claims Package by the creditor);

- d. if the Proposal Trustee and any Claimant disagree on the Claims, those disputes must be resolved through Application with the Court in accordance with the Disputed Claim Application (as defined in the Claim Procedure Order) process; and
- e. the Proposal Trustee will notify Unknown Claimants through publications in a newspaper notice and the Proposal Trustee's website in accordance with the Claims Procedure.

## **Relief Sought**

- 44. I do verily believe that Kaden has acted and is continuing to act in good faith and with due diligence in completing the preliminary work and preparation of a proposal to its creditors.
- 45. I make this Affidavit in support of an application by Kaden for: (i) an extension of the time within which to file a proposal; (ii) granting of an Administration Charge; (iii) approving the payment of certain Critical Suppliers; (iv) granting of the Directors' Charge; and (v) approving the Claims Procedure.

#### Purpose:

The purpose of the Cash Flow Statement is to demonstrate the Company's projected ability to fund its operations over the forecast period.

#### Assumptions:

1.Revenues collected on March 25 are based on our best estimate derived from truck tickets to estimate production. The monthly average was used to determine price and overall revenue for the month of February (to be collected in March). Later months' projected revenue is derived from our production estimates (using reserve reports and our forecast for production based on outages) and using strip pricing provided by Contango Marketing (Kaden's marketing party) to estimate revenue. It is then assumes revenue collections to be received the following month. April and May revenues will be impacted negatively due to a planned four week pipeline and gas facility outage by Pembina, in addition to Spring-Break up at Smoky.

2.As a result of the NOI filing, there is a "stay of proceedings" such that no amounts for goods and services provided to the company prior to the date of the NOI will be paid at this time. The forecast, however, includes payment for goods and services provided to and authorized following the date of the NOI, which have been forecast based on the assumptions noted below.

3.Royalties are estimated based on historical percentages (rates which vary by month depending on the royalty agreement and production/revenue by location) and projected revenue over the forecast period.

4.Monthly operating costs are calculated based on historical per "BOE" calculations and projected production figures, adjusted for outages and down periods noted, assumed to be paid in the following month. We are also assuming a weekly \$45,000 amount will be paid to pre-pay for critical services for the first two month, then \$20,000 subsequent, as the company is current on recent invoices.

5.Assume G&A is settled in the month occurred, except for payroll which is semi-monthly. Included in the payment of salaries the week of March 11, 2024 is \$22,000 of pre-filing NOI wages which are necessary to be paid to support ongoing operations. Approximate historical G&A is \$135,000 per month. A one-time annual cost for reserve reports is noted during the week of April 29.

6.GST is calculated based on net revenues and expenses post NOI, payable the following month.

7.Assuming additional costs to be incurred related to restructuring, including the professional fees to the Proposal Trustee and the company's legal counsel, at a rate of \$50,000 per month.
