TAKE NOTICE that on July 10, 2020, each of Conian Developments Ltd. ("**Conian**"), Conian Developments (La Voda II) Inc. ("**La Voda II**"), and FLII Construction Ltd. ("**FLII**", and together with Conian, La Voda I, and La Voda II, the "**Debtors**") was deemed to have made an assignment in bankruptcy as a result of failing to file a Proposal pursuant to the *Bankruptcy and Insolvency Act* and McEown & Associates Ltd. ("**McEown**") was appointed as the trustee in bankruptcy of each of the Debtors. Subsequently, on March 17, 2022, BDO Canada Limited ("**BDO**") was substituted for McEown as the trustee in bankruptcy of each of the Debtors (in such capacity, the "**Trustee**").

TAKE NOTICE that pursuant to an Order of the Supreme Court of British Columbia made on July 20, 2023 (the "Claims Process Order"), the Trustee has been authorized to conduct a Claims Process for the determination of Claims of Direct Lenders and Ordinary Creditors against the Debtors. Capitalized terms not defined within this notice shall have the meaning ascribed thereto in the Claims Process Order.

TAKE NOTICE that any Person who (i) participated in the Loan Scheme and believes that they are a Direct Lender and has a Claim against one of more of the Debtors, or who believes that they are an Ordinary Creditor and has a Claim against one of more of the Debtors; and (ii) did not receive a Claims Package from the Trustee, must deliver to the Trustee a properly completed Proof of Claim form on or before 5:00 p.m. (Local Vancouver Time) on October 2, 2023 (the "Claims Bar Date").

IF ANY DIRECT LENDER OR ORDINARY CREDITOR FAILS TO FILE A PROOF OF CLAIM WITH THE TRUSTEE BY THE CLAIMS BAR DATE, THEN SUCH DIRECT LENDER OR ORDINARY CREDITOR WILL BE BARRED FROM MAKING OR ENFORCING A CLAIM IN THE BANKRUPTCIES OF ANY OF THE DEBTORS AND WILL NOT BE ENTITLED TO RECEIVE ANY NOTICE OR DISTRIBUTION IN THE BANKRUPTCIES AND SUCH CLAIM(S) THE DIRECT LENDER OR ORDINARY CREDITOR MAY HAVE AGAINST ANY OF THE DEBTORS SHALL BE FOREVER EXTINGUISHED.
