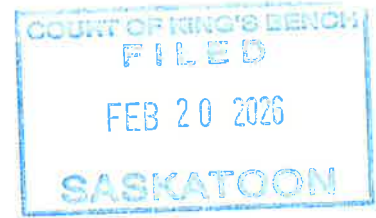

**RECITALS**

- A. Pursuant to the Receivership Order of this Court dated September 11, 2025, BDO Canada Limited was appointed as the receiver (the "**Receiver**") of the assets, undertakings and property of ThreeOSix Industrial Services Inc., 102056994 Saskatchewan Ltd., ThreeOSix Mining Services Inc., and BL Construction Services Ltd. (the "**Debtors**").
- B. Pursuant to an Order of the Court dated the 15th day of December, 2025, the Court approved the auction proposal (the "**Premises Equipment Auction Proposal**") between the Receiver and McDougall Auctioneers Ltd. (the "**Premises Equipment Auctioneer**") and provided for the vesting in the Premises Equipment Auctioneer of the Debtors' right, title and interest in and to the Premises Equipment, which vesting is to be effective with respect to the Premises Equipment upon the delivery by the Receiver to the Premises Equipment Auctioneer of a certificate confirming (i) the payment by the Premises Equipment Auctioneer of the purchase price for the Premises Equipment in accordance with the terms of the Premises Equipment Auction Proposal; and (ii) the Premises Equipment Transaction has been completed to the satisfaction of the Receiver.
- C. Unless otherwise indicated herein, terms with initial capitals have the meanings set out in the Premises Equipment Auction Proposal.

**THE RECEIVER CERTIFIES** the following:

1. The Premises Equipment Auctioneer (or its nominee) has paid and the Receiver has received the purchase price for the Premises Equipment payable pursuant to the Premises Equipment Auction Proposal;
2. The Premises Equipment Transaction has been completed to the satisfaction of the Receiver; and
3. This Certificate was delivered by the Receiver at 3:30 p.m. on the 19<sup>th</sup> day of February, 2026.
