PROCEDURAL ORDER

Before the Honourable Justice Alexander MacDonald on October 1, 2025

WHEREAS the Applicants filed a Notice of Application pursuant to the *Companies' Creditors Arrangement Act*, as amended (the "CCAA") for, *inter alia*, approval of an Approval and Vesting Order and increase in the Administrative Charge;

AND WHEREAS the Monitor, BDO Canada Limited, filed a Notice of Application pursuant to the CCAA for, *inter alia*, a distribution order;

AND WHEREAS the Bank of Montreal filed, but has not served the Service List, a Notice of Application pursuant to the *Bankruptcy and Insolvency Act*, as amended, for, *inter alia*, appointment of MNP Ltd. as the Court appointed receiver of the property, assets and undertaking of the Applicants;

UPON HEARING the submissions of counsel for the Karwood, the Monitor, the Bank of Montreal, and such other counsel that were present, no one else appearing for any party although duly served:



- 1) **THIS COURT ORDERS** that the Notice of Applications filed by the Applicants, the Monitor and BMO are adjourned to October 23, 2025, at 2:00 p.m.
- 2) **THIS COURT ORDERS** that any party contesting the Applications shall file and serve their opposition submission and affidavits(s) on the Service List by no later than 12:00 p.m. on October 10, 2025;
- 3) **THIS COURT FURTHER ORDERS** that any party seeking to question the Monitor shall do so by filing and serving interrogatories on the Monitor and its counsel (with copies to the service list) by no later than 12:00 p.m. on October 10, 2025;
- 4) **THIS COURT FURTHER ORDERS** any party filing a reply to the Applications shall file and serve their submission in reply and affidavit(s) on the Service List by no later than 12:00 p.m. on October 16, 2025;
- 5) **THIS COURT FURTHER ORDERS** that the Monitor shall file and serve its answer to interrogatories and any further report on the Service List by no later than 12:00 p.m. on October 21, 2025;
- 6) **THIS COURT ORDERS** that this Order and all of its provisions are effective as of 12:01 a.m. Newfoundland Time on the date of this Order.
