Endorsement of Penny J. – January 14, 2022

There are two scheduling matters to be dealt with in this proceeding.

First, there is a motion to extend the receivership to include a property over which the creditor has a third mortgage. That motion is scheduled for January 24, 2022 at 10:00 AM for one hour.

Second, since my endorsement of November 24, 2021, Mr. Byrd has retained counsel and filed a substantive defence, including an expert report, responding to the creditor's motion for judgment on a personal guarantee. Counsel have agreed that this will require a significant hearing, possibly with limited *viva voce* evidence. They have agreed to a timetable (below) which I endorse. That motion shall proceed on January 27 to 29, 2022.
