THE APPLICATION of BDO Canada Limited in its capacity as Court-appointed Receiver (the "Receiver") of the assets, undertakings and properties of Briere Production Group Inc. ("Production") and Briere Transportation Ltd. (collectively the "Companies"), coming on for hearing at Vancouver, British Columbia, on this day; AND ON HEARING Jonathan B. Ross and Amarit P. Bains, counsel for the Receiver, and those other counsel listed on Schedule "A" hereto, and no one else appearing although duly served; AND UPON READING the material filed, including the First Report of the Receiver, dated July 9, 2025;

THIS COURT ORDERS AND DECLARES THAT:

1. The service of the Notice of Application and supporting materials in regard to this order on the parties on the service list attached as Schedule "B" hereto by e-mail is good and sufficient service and the time for such service is abridged to the date of actual service;

2. The sale transaction (the "**Transaction**") contemplated by the Asset Purchase Agreement dated June 27, 2025 <sup>as amended on July 21, 2025</sup> (the "**Sale Agreement**") between the Receiver and Sound Waves Entertainment Network Ltd. (the "**Purchaser**"), a copy of which is attached as Schedule "**C**" hereto is hereby approved, and the Sale Agreement is commercially reasonable. The Receiver is hereby authorized and directed to take such additional steps and execute such additional documents as may be necessary or desirable for the completion of the Transaction and for the conveyance to the Purchaser of the Purchased Assets (as defined in the Sale Agreement) (the "**Purchased Assets**");
  
3. Upon payment of the purchase price to the Receiver, all of Production's right, title and interest in and to the Purchased Assets described in the Sale Agreement shall vest absolutely in the Purchaser in fee simple, free and clear of and from any and all security interests (whether contractual, statutory, or otherwise), hypothecs, mortgages, trusts or deemed trusts (whether contractual, statutory, or otherwise), liens, executions, levies, charges, or other financial or monetary claims, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, the "**Claims**") including, without limiting the generality of the foregoing: (i) any encumbrances or charges created by any Order of this Court made herein; (ii) all charges, security interests or claims evidenced by registrations pursuant to the *Personal Property Security Act* of British Columbia or any other personal property registry system (all of which are collectively referred to as the "**Encumbrances**") and, for greater certainty, this Court orders that all of the Encumbrances affecting or relating to the Purchased Assets are hereby expunged and discharged as against the Purchased Assets;
  
4. For the purposes of determining the nature and priority of Claims, the net proceeds from the sale of the Purchased Assets shall stand in the place and stead of the Purchased Assets, and from and after the payment of the purchase price all Claims shall attach to the net proceeds from the sale of the Purchased Assets with the same priority as they had with respect to the Purchased Assets immediately prior to the sale, as if the Purchased Assets had not been sold and remained in the possession or control of the person having had possession or control immediately prior to the sale;


5. The Closing Date of the Transaction shall be two (2) business days after the date of this Order;
6. The Receiver, with the consent of the Purchaser, shall be at liberty to extend the Closing Date to such later date as those parties may agree without the necessity of a further Order of this Court;
7. Notwithstanding:
  - (a) these proceedings; and
  - (b) the Receivership Order pronounced April 10, 2025,

the vesting of the Purchased Assets in the Purchaser pursuant to this Order shall be binding on any trustee in bankruptcy that may be appointed in respect of the Companies and shall not be void or voidable by creditors of the Companies, nor shall it constitute or be deemed to be a transfer at undervalue, fraudulent preference, assignment, fraudulent conveyance or other reviewable transaction under the *Bankruptcy and Insolvency Act* or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation;


8. THIS COURT HEREBY REQUESTS the aid and recognition of any court, tribunal, regulatory or administrative body, wherever located, to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order;
9. The Receiver or any other party have liberty to apply for such further or other directions or relief as may be necessary or desirable to give effect to this Order.

10. The approval of this Order by counsel appearing, other than counsel for the Receiver, is hereby dispensed with.

**ASSET PURCHASE AGREEMENT**

This Asset Purchase Agreement (the "**Agreement**") made as of June 27, 2025,

BETWEEN:

**BDO CANADA LIMITED,**

in its capacity as court-appointed receiver of all assets and undertakings of Briere Production Group Inc. and Briere Transportation Ltd., and not in its personal or corporate capacity, having an office at 1100 – 1055 West Georgia St, Vancouver, British Columbia V6E 3P3

(the "**Vendor**")

AND:

**SOUND WAVES ENTERTAINMENT NETWORK LTD.,**

a company incorporated under the laws of British Columbia having its registered office at 301 – 1665 Ellis Street Kelowna, British Columbia, V1Y 2B3

(the "**Purchaser**")

WHEREAS:

- A. Pursuant an order (the "**Receivership Order**") of the Supreme Court of British Columbia made on April 10, 2025 in Supreme Court of British Columbia (the "**Court**") Action Number S-251915, Vancouver Registry (the "**Receivership Action**"), the Court made an Order, effective May 1, 2025, appointing the Vendor as the receiver of all of the assets, undertakings and property of Briere Production Group Inc. ("**BPG**") and Briere Transportation Ltd. ("**BT**") ("collectively herein referred to as the **Companies**") with the power and authority to, among other things, market and sell the assets of the Companies in accordance with the terms of the Receivership Order;
- B. Prior to the Receivership Action BPG operated a production services business known as "Briere Production Group" (the "**Business**");
- C. Subject to approval of the Court, the Purchaser has agreed to purchase from the Vendor, and the Vendor has agreed to sell to the Purchaser, the Purchased Assets (as defined herein), upon and subject to the terms and conditions of this Agreement (the "**Transaction**").

NOW, THEREFORE, in consideration of the premises and the mutual covenants contained in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties intending to be legally bound agree as follows:

**ARTICLE 1  
DEFINITIONS****1.1 Certain Defined Terms**

As used in this Agreement, the following terms shall have the following meanings and grammatical variations of such terms shall have corresponding meanings:

**"Accounts Receivable"** means all accounts, notes, bills, trade accounts, volume rebates and trade receivables of the Companies, or such portion as remains owing to the Companies on the Closing Date.

**"Agreement"** means this asset purchase agreement including all exhibits and schedules and all amendments or restatements, as permitted.

**"Applicable Law"** means any domestic or foreign statute, law (including the common law), ordinance, rule, regulation, restriction, by-law (zoning or otherwise), order, or any consent, exemption, approval or licence of any Governmental Authority, that applies in whole or in part to the Transaction, the Vendor, the Purchaser, the Business, or any of the Purchased Assets.

**"Approval and Vesting Order"** means a Court order substantially in the form of the BC Model Approval and Vesting Order, with any amendments thereto to be acceptable to the Vendor and the Purchaser, each acting reasonably, which shall, among other things:

- (a) authorize and approve this Agreement and the execution and delivery thereof by the Vendor;
- (b) authorize and direct the Vendor to complete the Transaction;
- (c) vest the Purchased Assets in the Purchaser upon filing of a Receiver's Certificate; and
- (d) provide for the vesting off of title to the Purchased Assets all Encumbrances other than Permitted Encumbrances, upon the delivery of a Receiver's Certificate to the Purchaser.

**"Approval Date"** has the meaning specified in Section 10.1.

**"Business"** has the meaning specified in Recital B.

**"Claims"** means any claims, obligations, demands, costs, damages, expenses, losses, damages (including special, punitive, exemplary, consequential and indirect damages), charges, suits, orders, actions, proceedings (governmental, administrative or otherwise), judgments, reviews, inquiries, investigations, audits, obligations and debts, including interest, penalties, fines, court costs and reasonable lawyer's fees and disbursements.

**"Closing"** means the closing of the Transaction.

**"Closing Date"** means 2 business days after the Approval and Vesting Order is granted, or such other date as the Parties may agree;

**"Closing Documents"** means the documents referred to in Sections 11.1 and 11.2 hereof.

**"Companies"** means BPG and BT.

**"Counted Assets"** means the Equipment and Inventory that was counted by representatives of the Purchaser and the Vendor on June 26, 2025, the quantities of which are set out in **Schedule A**.

**"Court"** means the Supreme Court of British Columbia.

**"Court Approval"** means the approval of the Transaction by the Court by way of the issuance of the Approval and Vesting Order.

"**Deposit**" has the meaning specified in Section 2.4.

"**Documents**" has the meaning specified in Section 14.5.

"**Encumbrances**" means with respect to the Purchased Assets any financial charge or encumbrance of whatever kind or nature, regardless of form, whether or not registered or registrable and whether or not consensual or arising by law (statutory or otherwise), including any mortgage, charge, pledge, hypothecation, security interest, lien, restrictive or statutory covenant, lease, licence, assignment, option or claim, or right of any Person of any kind or nature whatsoever or howsoever arising which may constitute or become by operation of law or otherwise an encumbrance on any of the Purchased Assets.

"**Environmental Laws**" means any law, bylaw, order, ordinance, ruling, regulation or directive of any applicable federal, provincial, territorial, municipal, local or other government or governmental department agency or regulatory authority or any court of competent jurisdiction relating to environmental matters and/or regulating the import, manufacture, storage, distribution, labelling, sale, use, handling, transport or disposal of Hazardous Substances, as are in force as of the Closing Date.

"**Equipment and Inventory**" means all machinery, equipment, inventory, office equipment, yard equipment, furniture, furnishings, spare parts, tools, stores and supplies of all kinds used in connection with the Business including, such as it exists at Closing and without any representation of the Vendor, that equipment and inventory set out in **Schedule B**.

"**ETA**" has the meaning specified in Section 2.6(a).

"**Excluded Assets**" means all of the Companies' right, title and interest in and to the following:

- (a) all shares of capital stock or other equity interests in securities in any entity;
- (b) Accounts Receivable; and
- (c) 2023 Ford F450, Vehicle ID: 1FT8W4DM4PED65445 released by the Receiver

"**Goodwill**" means the goodwill of the Business and the right of the Purchaser to represent itself as carrying on the Business in continuation of and in succession to BPG and the right to use the name "Briere Production Group" or any variation of that name as part of or in connection with the Business.

"**Governmental Authority**" means any Canadian federal, provincial, municipal or local or governmental, regulatory or administrative authority, agency or commission or any court, tribunal, or judicial or arbitral body or any other public agency having jurisdiction with respect to the Companies, the Purchased Assets or any other matter that is the subject of this Agreement.

"**GST**" has the meaning specified in Section 2.6(a).

"**GST Certificate**" has the meaning specified in Section 2.6(a).

"**Hazardous Substances**" means any underground storage tanks, any explosive or radioactive materials, pollutants, contaminants, hazardous, corrosive or toxic substances, special waste or waste of any kind, including, without limitation, compounds known as chlorobiphenyls, petroleum and any other substance or material, the storage, manufacture, disposal, treatment, generation, use, transportation, remediation or release into the environment of which is prohibited, controlled, regulated or licensed under Environmental Laws.

**"Intellectual Property"** means all trade-marks, trade names, business names, service names, copyrights, patents, technology rights, inventions, computer software, Internet protocol addresses and domain names associated with the Business, including, trade secrets, know-how, industrial designs and other industrial or intellectual property and all applications therefor including, all licences or similar rights used by or granted to BPG in connection therewith.

**"Liabilities"** means all costs, expenses, charges, debts, liabilities, amounts owing, claims, demands and obligations, whether primary or secondary, direct or indirect, fixed, secured or unsecured, accrued, contingent, known or unknown, absolute or otherwise.

**"Lougheed Premises"** has the meaning set out in Article 2.8.

**"Mutual Condition"** has the meaning specified in Section 10.1.

**"Parties"** means the parties to this Agreement and **"Party"** means any one of the parties to this Agreement, as the context requires.

**"Permitted Encumbrances"** means those registered encumbrances against title to the Purchased Assets, specified as such in **Schedule C**.

**"Person"** means any individual, partnership, limited partnership, limited liability company, firm, corporation, association, trust, joint venture, joint-stock company, society, unincorporated organization or other entity.

**"PST"** has the meaning specified in Section 2.6(a).

**"Purchased Assets"** means all of BPG's right, title and interest in and to the following:

- a) the Equipment and Inventory;
- b) the Intellectual Property;
- c) the Goodwill;
- d) the Records; and
- e) the Referral Listings;

but excluding all Excluded Assets.

**"Purchaser's Lawyers"** means Pushor Mitchell LLP.

**"Purchase Price"** has the meaning specified in Section 2.2.

**"Receiver's Certificate"** means the certificate contemplated in the Approval and Vesting Order to be filed with the Court by the Vendor certifying that the Vendor confirms, and has received written confirmation in form and substance satisfactory to the Vendor from the Purchaser that it confirms, that all conditions to Closing have been satisfied or waived by the applicable Parties and that the Purchase Price and all applicable taxes payable by the Purchaser to the Vendor have been received by the Vendor's Lawyers.

**"Records"** means all books and records of BPG in connection with the Purchased Assets including but not limited to, copies of all accounting records, permits, all customer and supplier lists, inquiry logs,

records of referral sources, files, documents, books, manuals, research, reservations, price lists, correspondence and data bases, all in the form and on the medium or media used in the Business, and includes the Flex Rental Solutions account information, but excludes employee files.

"**Referral Listings**" means the telephone number 1-855-854-9317, the URL [www.briereproductiongroup.com](http://www.briereproductiongroup.com) and any social media accounts;

"**Vendor's Lawyers**" means Gowling WLG (Canada) LLP.

"**Viewed Assets**" means the assets located at the Lougheed Premises.

"**Third Party**" means a Person who is not a Party.

"**Transaction**" means the transaction of purchase and sale of the Purchased Assets contemplated by this Agreement.

## ARTICLE 2 PURCHASE AND SALE OF ASSETS

### 2.1 The Purchased Assets

Subject to the timely fulfillment or waiver of the terms and conditions of this Agreement, including the granting of the Approval and Vesting Order, the Vendor agrees to sell, and the Purchaser agrees to purchase, the Purchased Assets for the Purchase Price on the Closing Date free and clear of any and all Encumbrances, Liabilities, and Claims, except for Permitted Encumbrances.

### 2.2 Purchase Price

The purchase price (the "**Purchase Price**") payable by the Purchaser to the Vendor in consideration for the Purchased Assets shall be ~~\$4,730,000~~

**\$2,033,502**

### 2.3 Adjustment

- (a) Except as otherwise provided herein, the Vendor shall be responsible for all expenses and liabilities and shall be entitled to receive all revenues, accrued in respect of the Purchased Assets prior to the Closing Date. The Purchaser shall be responsible for all expenses and liabilities accruing from and including the Closing Date, and shall be entitled to receive all revenues accruing from and including the Closing Date in respect of the Purchased Assets.
- (b) Other than any required upward adjustment on account of GST, PST or other tax, there shall be no other adjustment to the Purchase Price.

## 2.4 Deposit and Payment of Purchase Price

The Purchaser shall pay the Purchase Price as follows:

- (a) \$173,750.00, by way of deposit (the "**Deposit**"), which the Vendor confirms receipt of on June 6, 2025, which Deposit the Vendor has or shall provide to the Vendor's Lawyer in trust, to be held in accordance with section 2.5, within 2 business days of execution of this Agreement by all Parties; and
- (b) the balance of the Purchase Price, as well as any GST, PST or other tax on the Deposit and balance, to be paid on closing by certified cheque, bank draft or wire transfer of immediately available funds to or to the order of the Vendor.

## 2.5 Terms of Deposit

The Deposit shall be held in trust by the Vendor's Lawyers, in a non-interest bearing trust account. The Deposit shall be dealt with as follows:

- (a) if the conditions precedent set out in section 8.1 or 9.1 have not been satisfied or waived by the Purchaser or the Vendor, as the case may be, on or before the Closing Date, then the Deposit shall be returned to the Purchaser immediately upon demand without any deduction, as the sole remedy of the Purchaser against the Vendor;
- (b) if this Agreement is terminated in accordance with section 13.1, then the Deposit shall be returned to the Purchaser immediately upon demand without any deduction, as the sole remedy of the Purchaser against the Vendor;
- (c) if the Mutual Condition is not satisfied by the Approval Date, then the Deposit shall be returned to the Purchaser immediately upon demand without any deduction, as the sole remedy of the Purchaser against the Vendor;
- (d) if the Mutual Condition is satisfied by the Approval Date, the conditions precedent set out in sections 8.1 and 9.1 have been waived or satisfied, and this Agreement has not been terminated in accordance with section 13.1, then on the Closing Date,
  - (i) the Deposit shall be credited on account of the Purchase Price on Closing;
  - (ii) if the Purchaser fails to complete the purchase of the Purchased Assets in accordance with this Agreement after all conditions to the Purchaser's obligation to complete have been satisfied or waived or if the Purchaser repudiates this Agreement, then, at the Vendor's option, the Deposit shall be forfeited to the Vendor as liquidated damages, but without prejudice to any other rights or remedies of the Vendor whether at law or in equity; or
  - (iii) if the Purchaser is not in default of any of its obligations under this Agreement and the Vendor fails to complete the sale of the Purchased Assets in accordance with this Agreement after all conditions to the Vendor's obligation to complete have been satisfied or waived or if the Vendor repudiates this Agreement, then the Deposit shall be refunded to the Purchaser upon demand by the Purchaser, as the sole remedy of the Purchaser against the Vendor.

## 2.6 Taxes

- (a) The Purchase Price does not include the goods and services tax ("GST") or British Columbia provincial sales tax ("PST") payable with respect to the acquisition of the Purchased Assets in accordance with Part IX of the *Excise Tax Act* (Canada) (the "ETA") and *Provincial Sales Tax Act* (British Columbia) (the "PSTA"), which are the sole responsibility of the Purchaser and shall be payable as of the closing in the same manner as the Purchase Price.
- (b) The Purchaser represents and warrants to the Vendor that it is and shall be, as of the closing on the Closing Date, registered for GST purposes under the ETA. The Vendor represents and warrants to the Purchaser that it is registered for GST purposes under the ETA, and shall be as of the closing on the Closing Date. The Purchaser shall indemnify and hold the Vendor and its directors, officers, employees, advisors and agents harmless from any liability under the ETA arising as a result of any breach of the ETA with respect to GST payable in respect of the Purchased Assets, this Section 2.6, and such indemnity shall survive Closing.
- (c) The Purchaser acknowledges that it may be liable to pay PST in respect of its purchase of some or all of the Purchased Assets. The Purchaser shall indemnify and hold the Vendor and their directors, officers, employees, advisors and agents harmless from any liability related to the Purchaser's or the Vendor's failure to account for, or report and remit such PST and such indemnity shall survive Closing.
- (d) Notwithstanding the above, the Vendor shall cooperate with the Purchaser to execute any election available under Applicable Law that may reduce or defer the amount or due date of any GST or PST, or other tax payable by the Purchaser, provided such election shall not result in any increased cost or tax liability for the Vendor. At the Closing, if available in respect of the Transaction, each of the Vendor and the Purchaser shall execute jointly an election under subsection 167(1) of Part IX of the ETA, in the prescribed form and within the prescribed time therefor, in respect of the sale and transfer of the Purchased Assets and the Purchaser shall file such election with the Canada Revenue Agency.
- (e) The Purchaser shall be responsible for all property and other transfer taxes, fees and expenses in connection with any registration of the Approval and Vesting Order or transfer of the Purchased Assets and the Vendor shall be responsible for income taxes or fees in respect of the disposition of the Purchased Assets.

## 2.7 Allocation of Purchase Price

The Purchase Price shall be allocated between the Purchased Assets as follows:

- (a) the ~~Equipment and Inventory~~ - ~~\$1,740,000.00~~, **2,023,500**
- (a) **the Equipment \$ 5,000**
- (b) the Intellectual Property - ~~\$10,000.00~~, **\$ 5,000**
- (c) the Records - \$1.00;
- (d) the Referral Listings - \$1.00; and

- (e) the Goodwill – the balance of the Purchase Price.

## **2.8 Removal of Purchased Assets from Premises by the Purchaser Upon Closing**

The Purchased Assets are sold on an "as is where is" basis. The Vendor agrees to deliver the Purchased Assets that are Viewed Assets to the Purchaser on Closing at Unit 150, 8061 Lougheed Highway, Burnaby, BC (the "**Lougheed Premises**"), and the Purchaser shall, at its own expense:

- (a) completely remove the Purchased Assets that are Viewed Assets from the Lougheed Premises; and
- (b) leave the Lougheed Premises in a broom-swept condition;

no later than 5 business days after the Closing Date.

## **ARTICLE 3 REPRESENTATIONS AND WARRANTIES OF THE VENDOR**

### **3.1** The Vendor represents and warrants to the Purchaser that:

- (a) subject to the Approval and Vesting Order being granted, the Vendor has the power, authority and capacity to enter into this Agreement, subject to its terms;
- (b) the Vendor is not a non-resident of Canada under the Income Tax Act (Canada); and
- (c) the Counted Assets will be in the same condition and quantities on the Closing Date as they were on the dates that the Purchaser and the Vendor counted the Counted Assets, being June 26, 2025.

### **3.2** The Purchaser acknowledges and agrees that the Vendor makes no representations or warranties of any kind whatsoever, expressed or implied, with respect to the Purchased Assets except as expressly warranted by the Vendor in this Agreement. Except as expressly warranted by the Vendor in this Agreement, the Purchaser shall be deemed to have relied solely and entirely upon its own investigations and inspections of and with respect to the Purchased Assets. To the extent that any information which the Vendor has provided to the Purchaser is based on the records of the Companies, the Vendor makes no representation whatsoever with respect to the accuracy of any such information.

## **ARTICLE 4 REPRESENTATIONS AND WARRANTIES OF PURCHASER**

### **4.1** The Purchaser hereby represents and warrants to the Vendor as follows, with the intent that the Vendor shall rely on these representations and warranties in entering into this Agreement, and in concluding the Transaction contemplated by this Agreement:

- (a) the Purchaser is a duly formed and registered corporation existing pursuant to the laws of the jurisdiction of its incorporation;

- (b) the Purchaser has the power and authority to execute and deliver this Agreement and the other documents and instruments contemplated herein or therein to which it is or shall be a party and to perform its obligations hereunder and thereunder. The execution, delivery and performance of this Agreement and the documents contemplated hereby and the consummation of the transaction contemplated hereby and thereby have been duly authorized and approved by the Purchaser;
- (c) this Agreement, and if, as, and when executed, each of the other agreements, documents and instruments to be executed and delivered by the Purchaser on or before the Closing, have been or shall upon such execution and delivery be duly executed and delivered by, and constitute the valid and binding obligations of the Purchaser, in accordance with their terms;
- (d) the execution and delivery by the Purchaser of this Agreement and the performance by the Purchaser of its obligations under this Agreement shall not result in the breach or violation of any terms or conditions of: (i) the constating documents or by-laws of the Purchaser; or (ii) any applicable law, regulation or order; and
- (e) the Purchaser shall be a registrant for purposes of Part IX of the Excise Tax Act (Canada) on the Closing Date and its registration number shall be provided as part of the Closing; or alternatively the Purchaser shall remit to the Vendor all applicable GST.
- (f) the Purchaser is not a non-Canadian within the meaning of the *Investment Canada Act* (Canada) or the *Prohibition on the Purchase of Residential Property by Non-Canadians Act* (Canada) and the regulations made thereunder, and shall not be as of the Closing Date.

## **ARTICLE 5 SURVIVAL OF REPRESENTATIONS**

- 5.1** The representations and warranties of each Party contained in this Agreement will not merge on and will survive the Closing and will continue in full force and effect, notwithstanding the Closing or any investigation or knowledge acquired by or on behalf of the other Party.
- 5.2** The Vendor shall have no obligation whatsoever in respect of a claim (for indemnification or otherwise) for a breach of a representation or warranty under this Agreement unless written notice of that claim, containing full particulars of that claim, is delivered to the Vendor on or before the following dates:
  - (a) with respect to the representations and warranties set out in sections 3.1(a) and 3.1(b), at any time after the Closing Date; and
  - (b) with respect to the representations and warranties set out in section 3.1(c), on or before the date that is one (1) day after the Closing Date or the date that the Purchaser begins removing the Purchased Assets from the Loughheed Premises, whichever is earlier.
- 5.3** The Purchaser has no obligation to make any payment for damages in respect of a claim (for indemnification or otherwise) for a breach of a representation or warranty under this Agreement unless written notice of that claim is delivered to the Purchaser on or before the following dates:

- (a) with respect to the representations and warranties set out in sections 4.1, at any time after the Closing Date.

## **ARTICLE 6 ACKNOWLEDGEMENT BY PURCHASER**

### **6.1 "As Is, Where Is"**

the Purchaser hereby acknowledges that subject to Article 3.1(c) the Vendor is selling the Purchased Assets on an "as is, where is" basis as they exist on the date hereof. The Purchaser further acknowledges that it has conducted any and all diligence and inspections as to title, encumbrances, description, fitness for purpose, merchantability, condition, quantity, quality, assignability and condition of the Purchased Assets that it deemed appropriate, and has satisfied itself with regard to this matter. No representation, warranty or condition is expressed or can be implied as to title, encumbrances, description, fitness for purpose, merchantability, condition, quantity, quality, assignability or in respect of any other matter or thing concerning the Purchased Assets or the right of the Vendor to sell them, save as expressly represented or warranted in this Agreement. Without limiting the generality of the foregoing, any and all conditions, warranties or representations expressed or implied pursuant to the Sale of Goods Act (British Columbia) or similar legislation in any other jurisdiction do not apply to this transaction of purchase and sale and have been waived by the Purchaser.

### **6.2 Obtaining Consent**

The Purchaser hereby expressly acknowledges that: (i) if any consents of any Person or third parties are required to effect the transfer of any of the Purchased Assets to the Purchaser pursuant to this Agreement, then it is the sole responsibility of the Purchaser to obtain any such consents, and the granting of any such consents shall not be a condition precedent to the Purchaser's obligations under this Agreement, including the payment of the Purchase Price; and (ii) all costs and other liabilities associated with obtaining any such consents are the sole obligation of the Purchaser.

### **6.3 Vendor's Capacity**

The Purchaser acknowledges that the Vendor is entering into this Agreement solely in its capacity as the court-appointed receiver and manager of the Companies and not in its personal or corporate capacity. The Purchaser acknowledges that the Vendor is selling the right, title, and interest of BPG in the Purchased Assets pursuant to the Receivership Order and the Approval and Vesting Order. The Purchaser agrees to purchase and accept the right, title, and interest of BPG in and to the Purchased Assets pursuant to and in accordance with the terms of this Agreement and any other agreements required to be delivered pursuant to the terms of this Agreement. The acceptance by the Vendor of this Agreement is expressly subject to Court Approval and all such other orders that the Court may make.

## **ARTICLE 7 COVENANTS OR APPROVALS**

### **7.1 Consents**

The Purchaser shall take, or cause to be taken, and the Vendor shall as may be requested by the Purchaser take or cause to be taken, all commercially reasonable actions and as may be necessary, proper or advisable to permit and diligently pursue completion of the Transaction

contemplated by this Agreement in accordance with the terms hereof, including obtaining the authorization, approval or consent of any Governmental Authority and shall co-operate with each other in connection therewith, including using all commercially reasonable efforts to obtain as soon as reasonably possible and in any event, prior to the Closing Date any consents required from any Governmental Authority having jurisdiction over the Purchased Assets, provided that the Purchaser shall fully indemnify the Vendor against its reasonable costs and expenses incurred by the Vendor for services requested by the Purchaser in connection with obtaining the consents, if any, required under this Section 7.1.

## **7.2 Transfer of Purchased Assets**

In connection with transfer and assignment of the Purchased Assets, the Vendor shall at the request and sole cost of the Purchaser take all such actions and do, or cause to be done, all such things at the request of the Purchaser as shall reasonably be necessary in order to transfer or assign the Purchased Assets, including but not limited to any licenses, permits, and Intellectual Property, to the Purchaser, but only to the extent the same are transferable.

## **7.3 Change Name**

The Vendor shall make commercially reasonable efforts to cause BPG to change its name to a name that does not contain any of the words "Briere Production Group" and that is not confusingly similar to its present name, and deliver to the Purchaser a photocopy of the certificate of amendment evidencing that those articles of amendment have been filed within 30 business days of the Closing Date.

## **ARTICLE 8 CONDITION PRECEDENT IN FAVOUR OF THE PURCHASER**

**8.1** The obligations of the Purchaser under this Agreement are subject to the fulfillment of the following conditions precedent:

- (a) each of the representations and warranties of the Vendor set forth in Section 3.1 shall be true and correct as if restated on and as of the Closing Date;
- (b) the covenants and obligations contained in this Agreement to be complied with by the Vendor on or before the Closing shall have been complied with and not been breached in any material respect; and
- (c) on or before the Closing Date, the Vendor shall have delivered all items which it is required to deliver to the Purchaser pursuant to Section 11.1

**8.2** The Purchaser may, in its sole discretion, waive any of the foregoing conditions.

**8.3** If any one of the conditions precedent contained in Section 8.1 has not been satisfied or waived by the Purchaser on or before the Closing Date, the Purchaser may terminate this Agreement by written notice to the Vendor but Section 2.5 shall survive such termination.

## **ARTICLE 9**

## CONDITION PRECEDENT IN FAVOUR OF THE VENDOR

- 9.1** The obligations of the Vendor under this Agreement are subject to the fulfillment of the following conditions precedent:
- (a) each of the representations and warranties of the Purchaser set forth in Section 4.1 shall be true and correct as if restated on and as of the Closing Date;
  - (b) the covenants and obligations contained in this Agreement to be complied with by the Purchaser on or before the Closing shall have been complied with and not been breached in any material respect; and
  - (c) on or before the Closing Date, the Purchaser shall have delivered all items which it is required to deliver to the Vendor pursuant to Section 11.2.
- 9.2** The Vendor may, in its sole discretion, waive any of the foregoing conditions. Any waiver by the Vendor must be in writing and delivered to the Purchaser's Lawyers.
- 9.3** If any one of the conditions precedent contained in Section 9.1 has not been satisfied or waived by the Vendor on or before the Closing Date, the Vendor may terminate this Agreement by written notice to the Purchaser but Section 2.5 shall survive such termination.

## ARTICLE 10 COURT APPROVAL

### 10.1 Court Approval

The obligation of the Parties to complete the transactions contemplated by this Agreement shall be subject to the following mutual conditions (collectively the "**Mutual Condition**"), for the benefit of both the Vendor and the Purchaser:

- (a) that on or before July 25, 2025, or such later date as the Vendor and Purchaser may agree to in writing (the "**Approval Date**"), the Vendor shall have obtained the Approval and Vesting Order satisfactory to the Vendor and the Purchaser; and
- (b) there shall be in effect no order, injunction, judgment, decree, ruling, writ, assessment or arbitration award of the Court or other court of competent jurisdiction or of a relevant Government Entity prohibiting the consummation of the transactions contemplated hereby and which has not been withdrawn or terminated.

The Mutual Condition is for the mutual benefit of the Vendor and the Purchaser and may not be waived unilaterally by either Party. Both Parties agree that they shall use all reasonable commercial efforts to satisfy the Mutual Condition. If the Mutual Condition has not been satisfied by the Approval Date, then the Purchaser's and Vendor's obligation to complete the Transaction pursuant to this Agreement shall be at an end.

### 10.2 Appeals

For greater certainty, expiration of the appeal period for the Approval and Vesting Order shall not be a pre-condition of the Purchaser's or Vendor's obligation to complete the within transaction.

### **10.3 Competing Bids**

The Purchaser hereby acknowledges and agrees that notwithstanding acceptance of this offer by the Vendor: (i) another prospective purchaser may make an offer for the Purchased Assets, including without limitation at the hearing of the application for the Approval and Vesting Order; (ii) the Vendor is duty bound to and shall consider any such offers; and (iii) if any such offer is, in the Vendor's view, better for the Companies' stakeholders as a whole in comparison to this Transaction, the Vendor may recommend that the Court approve such other offer and not this Agreement. The Purchaser hereby acknowledges that it has been advised by the Vendor that, in order to protect its interests, the Purchaser should retain legal counsel to appear at the hearing of the application for the Approval and Vesting Order, including to make an amended or further offer for the Purchased Assets should that be necessary.

## **ARTICLE 11 CLOSING MATTERS**

### **11.1 Vendor's Closing Documents**

On the Closing Date, the Vendor shall deliver the following to the Purchaser's Lawyers, on the condition that the same shall only be dealt with in accordance with the procedure set out in ARTICLE 11:

- (a) a certified copy of the Approval and Vesting Order;
- (b) the Receiver's Certificate(s);
- (c) if applicable and available in respect of the Transaction, an election under section 167 of the ETA pursuant to Section 2.6;
- (d) possession of the Purchased Assets that are Viewed Assets; and
- (e) such other documents as may be requested by the Purchaser, acting reasonably, to effect the assignment, transfer and sale of the Purchased Assets as contemplated by this Agreement, to the extent not effected by the Approval and Vesting Order, in form and substance satisfactory to the Purchaser, acting reasonably.

### **11.2 The Purchaser's Closing Documents**

On the Closing Date, the Purchaser shall deliver the following to the Vendor's Lawyers, on the condition that the same shall only be dealt with in accordance with the procedure set out in ARTICLE 11:

- (a) payment of the balance of the Purchase Price pursuant to Section 2.4;
- (b) if applicable and available in respect of the Transaction, the GST Certificate or an election under section 167 of the ETA pursuant to Section 2.6;
- (c) such other documents as may be requested by the Vendor, acting reasonably.

### 11.3 Terms of Closing

None of the Closing Documents and monies shall be dealt with before Closing or until all deliveries contemplated by this ARTICLE 11 have been made, the Mutual Condition has been fulfilled, and the conditions precedent set out in section 9.1 or 8.1 have been waived or satisfied, except in accordance with Section 2.4 hereof.

## ARTICLE 12 PIPA PROVISIONS

### 12.1 Disclosure of Information

The Purchaser acknowledges and agrees that in the course of the Purchaser's due diligence in respect of the Purchased Assets, or through the Purchaser's purchase of the Records, the Purchaser has requested and may hereafter request and the Vendor has disclosed and may hereafter disclose certain personnel records and other information related to Purchased Assets and/or the business of the Companies that may include "personal information" (the "**Personal Information**") as defined in and subject to the British Columbia *Personal Information Protection Act* ("**PIPA**") and the Canada *Personal Information Protection and Electronic Documents Act* ("**PIPEDA**").

- (a) the Purchaser hereby confirms to the Vendor that the Personal Information that the Purchaser has requested or may hereafter request in the course of its due diligence is necessary in order for the Purchaser to determine whether to proceed with the proposed purchase of the Purchased Assets; and
- (b) the Purchaser hereby covenants and agrees that:
  - i. prior to Closing, any Personal Information that the Vendor discloses to the Purchaser shall be used by the Purchaser solely for purposes related to its due diligence and its proposed purchase of the Purchased Assets;
  - ii. if the proposed purchase of the Purchased Assets does not proceed or is not completed, the Purchaser shall destroy or return to the Vendor all of the Personal Information disclosed to the Purchaser by the Vendor in accordance with the Vendor's instructions; and
  - iii. if the proposed purchase of the Purchased Assets is completed: (i) the Purchaser shall only use or disclose the Personal Information for the same purposes for which it was collected, used or disclosed by the Vendor, or as otherwise permitted by and in accordance with PIPA and PIPEDA; and (ii) the Purchaser shall notify the individuals who are the subject of the Personal Information that the purchase of the Purchased Assets has taken place and that their Personal Information was disclosed to the Purchaser.

## ARTICLE 13 TERMINATION

### 13.1 Termination

In addition to termination pursuant to Sections 8.3 and 9.3, this Agreement may be terminated at any time prior to the Closing Date:

- (a) by mutual written consent of the Purchaser and the Vendor;
- (b) by the Purchaser or the Vendor if any court of competent jurisdiction or other Governmental Authority shall have issued an order, decree or ruling, or taken any other action specifically restraining, enjoining or otherwise prohibiting the transaction contemplated hereby, which order, decree, ruling or other action is not stayed or dismissed prior to the Closing Date; or
- (c) by either Party if the Mutual Condition is not satisfied by the Approval Date.

**ARTICLE 14  
MISCELLANEOUS**

**14.1 Risk of Loss**

Up to the time of the Closing, the Purchased Assets shall be and remain at the risk of the Vendor.

**14.2 Notices**

#### **14.3 Further Assurances**

At any time and from time to time after the date hereof each of the Parties hereto, at the reasonable request and expense of the other Party hereto, shall execute and deliver such other instruments of sale, transfer, conveyance, assignment, confirmation and other instruments as may be reasonably requested in order to more effectively transfer, convey and assign to the Purchaser and to confirm the Purchaser's title to the Purchased Assets and to effectuate the transaction contemplated herein.

#### **14.4 Legal Fees and Broker's Fees**

Each Party shall be responsible for and bear all of its own costs and expenses, including any broker's or finder's fees and the expenses of its legal and other representatives, incurred at any time in connection with pursuing and/or consummating the Transaction.

#### **14.5 Entire Agreement**

This Agreement together with the Schedules hereto and the other documents executed in connection herewith or referred to herein (together, the "**Documents**") embodies the entire agreement and understanding between the Parties hereto with respect to the subject matter hereof and supersedes all prior oral or written agreements and understandings relating to the subject matter hereof. No statement, representation, warranty, covenant or agreement of any kind not expressly set forth in the Documents shall affect, or be used to interpret, change or restrict, the express terms and provisions of the Documents.

#### **14.6 Modifications and Amendments**

The terms and provisions of this Agreement may be modified or amended only by written agreement executed by all Parties hereto and, where same may be required, by order of the Court.

#### **14.7 Assignment**

No Party to this Agreement may assign any of its rights or obligations under this Agreement without the prior written consent of the other Party.

**14.8 Parties in Interest**

This Agreement shall be binding upon and inure solely to the benefit of each Party hereto and their permitted assigns, and nothing in this Agreement, express or implied, is intended to confer upon any other person any rights or remedies of any nature whatsoever under or by reason of this Agreement. Nothing in this Agreement shall be construed to create any rights or obligations except among the Parties hereto, and no person or entity shall be regarded as a Third Party beneficiary of this Agreement.

**14.9 Governing Law**

This Agreement and the rights and obligations of the Parties hereunder shall be construed in accordance with and governed by the laws of British Columbia and the federal laws of Canada applicable therein.

**14.10 Headings and Captions**


The headings and captions of the various subdivisions of this Agreement are for convenience of reference only and shall in no way modify, or affect, or be considered in construing or interpreting the meaning or construction of any of the terms or provisions hereof.

**14.11 Counterparts**


