1. On the 21st day of December 2023, BDO Canada Limited became the Receiver and Manager (the “**Receiver**”) in respect of the assets, undertakings and properties (the “**Assets**”) of HBJR Holdings Ltd. (the “**Company**”).
2. BDO Canada Limited became a Receiver by virtue of being appointed by the Supreme Court of British Columbia pursuant to an Order of the Honourable Justice Wilkinson dated the 21st of December 2023 in Action No. S238583. A copy of the Court Order is attached.
