Chris,

I have the following instructions:

- The Receiver will pay \$50,000 in relation to and in full and final satisfaction of your pre-Receivership Order solicitor-client costs (which are in the range of \$92,000), subject to your obtaining an Order to this effect (which Order the Receiver will not oppose);
- The settlement in respect of your pre-Receivership Order costs will be without prejudice to the Receiver's position on your post-Receivership Order costs;
- With respect to your post-Receivership Order costs, your application will proceed in respect of those costs, and will be adjourned (by Consent Order) from tomorrow to be heard on the Commercial List at the first available date for which counsel is available;
- The Receiver will review those claimed post-Receivership Order costs and consider whether any of those costs
 were at the request of and for the benefit of the estate, with a view to having discussions with you with respect
 to whether a settlement of that cost claim might be possible;
- If we are unable to come to an agreement in respect of those post-Receivership Order costs, we will argue the matter at the return date of your application and proceed to a taxation if necessary.
