Please be advised 1390951 B.C. Ltd. (the "Company") was assigned into bankruptcy on November 20, 2024, with BDO Canada Limited appointed as the Licensed Insolvency Trustee (the "Trustee").

BDO Canada Limited is also acting as the Court appointed Receiver-Manager of the Company pursuant to an Order of the Court dated July 18, 2024. On September 17, 2024, the Court approved the sale of the assets of 1390951 B.C. Ltd. to 1494072 B.C. Ltd. This transaction completed on October 1, 2024. The purchaser of the assets has continued to operate the business under the same operating trade name at the same location subsequent to the closing date. The purchaser is a separate legal entity and is not liable for any of the debts owed by the Company. For greater certainty, the new operating company remains a going concern, and claims should only be filed for amounts owing prior to the sale closing date of October 1, 2024.
