SECOND SUPPLEMENTAL AFFIDAVIT OF RYAN MARTIN Sworn on April 13, 2021

I, Ryan Martin, of the City of Alberta, in the Province of Alberta, SWEAR AND SAY THAT:

1. I am the President, Secretary and sole director of the Applicants, Calgary Oil and Gas Intercontinental Group Ltd., formerly Triple Five Intercontinental Group Ltd. ("Intercontinental") and Petroworld Energy Ltd. ("Petroworld"). I have been the President of Intercontinental and Petroworld since September 4 and 10, 2020, respectively, and have been involved with the companies since their incorporation. Through my involvement with Intercontinental and Petroworld, I have also gained personal knowledge relating to their parent companies and related entities, Calgary Oil & Gas Syndicate Group Ltd., formerly Triple Five Energy Ltd., and Calgary Oil and Syndicate Partners Ltd., formerly T5 Energy Partners Ltd. (all Applicants are collectively referred to herein as the "Companies"). As such, I have personal knowledge of the matters to which I depose in this Affidavit, except where such matters are stated to be based on information and

- belief, in which case I have stated the source of my information and, in all cases, I believe such information to be true.
- 2. I previously swore an Affidavit on April 12, 2021 which was filed in these proceedings in support of the Companies' Application (the "Application") to be heard on April 13, 2021 (the "Hearing") for relief pursuant to the *Companies' Creditors Arrangement Act*, RSC 1985, c C-36, as amended.
- 3. In response to the materials filed by Westbrick Energy Ltd. ("Westbrick") in these proceedings (the "Cross-Application"), I believe the following additional information pertinent for the Hearing.
- 4. Throughout the last two weeks, I have engaged with the Sunchild First Nation ("SFN") on numerous occasions. In particular:
 - a. on March 24, 2021, I had dinner with Chief Jonathan Frencheater ("Chief Frencheater") and other members of the SFN Council, during which Chief Frencheater and the Council indicated its full support for the Companies' restructuring efforts;
 - b. on March 25, 2021, I texted Chief Frencheater of the SFN requesting a call. Attached hereto as **Exhibit** "A" is a true copy of this text message;
 - c. on March 29, 2021, I texted Clint McHugh of the SFN to attempt to set up a meeting on the restructuring plan. Attached hereto as **Exhibit** "B" is a true copy of this text message;
 - d. I am informed by the Companies' counsel, Steven Pearson of Borden Ladner Gervais LLP, and do believe that he spoke with Patrick Stratton, counsel for SFN, on March 30, 2021, with regards to Westbrick attempting to gain SFN support;
 - e. on April 1, 2021, I spoke with Chief Frencheater, Councillor Clint McHugh, Councillor Audrey Crooked Legs, Councillor Joey Pete, Shane Beston and other representatives of the SFN with regards to the ongoing process of obtaining new financing and the likely drilling program. I prepared an email summary of this conversation and asked Mr. McHugh to pass it to Chief Frencheater. Attached hereto as **Exhibit** "C" is a true copy of a text message that I sent to Clint McHugh confirming this conversation;
 - f. I am advised by the Companies' counsel, Mr. Pearson, and do believe, that he corresponded with Mr. Stratton on April 2, 2021 with respect to the Companies' plan to exit CCAA protection;
 - g. On April 5, 2021, I sent Chief Frencheater another text asking if he was free to discuss T5's offer. This text message is included in **Exhibit** "A". I also sent Clint McHugh a text

message asking for a call to discuss the restructuring of the Companies. Attached as **Exhibit** "**D**" is a true copy of this text message. I am advised by the Companies' counsel, Mr. Pearson, and do believe that he spoke with Mr. Stratton by phone on this date to inform SFN that the Companies were proceeding with an oil and gas counterparty that had financial resources and was willing to commit to a drilling program. Attached hereto as **Exhibit** "**E**" is a true copy of an email associated with this phone call.

- h. On April 6, 2021, I texted Mr. McHugh to set up a telephone call with representatives from the SFN, including Chief Frencheater. Mr. McHugh indicated that a call would happen the next day. I engaged in a telephone call with Shane Beston with respect to financing and the drilling program. Attached hereto as **Exhibit** "**F**" is a true copy of my text messages with Mr. McHugh on April 6, 2021.
- i. On April 7, 2021, I emailed Chief Frencheater, Mr. McHugh and Mr. Stratton to indicate that I looked forward to our call and that I was free for the vast majority of the day. Attached hereto as **Exhibit** "**G**" is a true copy of this email. I also texted Mr. McHugh to confirm whether a telephone call was going to take place that morning. Attached hereto as **Exhibit** "**H**" is a true copy of that text message. Ultimately, no telephone call took place that day.
- j. On April 8, 2021, the Companies' counsel emailed Mr. Stratton to signal that we were available for a call. Attached hereto as **Exhibit** "**I**" is a true copy of these emails. I texted Chief Frencheater at 8:39 AM to indicate that I was willing to provide full details of the restructuring plan. This text message is included in **Exhibit** "**A**". A telephone call between myself, Mr. Pearson, Mr. Stratton, Chief Frencheater and some (but not all) members of the SFN Council occurred at approximately 10:37 AM that day. I sent a follow up email to the call at 11:45 AM, indicating additional reasons why I believe that the Spartan deal was superior to Westbrick's offer. This email is included in **Exhibit** "**I**".
- k. On April 9, 2021 I texted Chief Frencheater to attempt to set up a telephone call between him, the SFN council, myself and Spartan to discuss the Spartan offer. This text message is included in **Exhibit** "A". I am advised by Mr. Pearson, and do believe, that he emailed Mr. Stratton to inquire if SFN was willing to have a dialogue with Fotis Kalantzis, President & Chief Executive Officer of Spartan and me. Mr. Stratton responded to this request on April 12, 2021 to indicate that SFN was unavailable for discussions. Attached hereto as **Exhibit** "J" is a true copy of this email discussion.

- I am also advised by Mr. Pearson that he corresponded with Mr. Stratton on April 9, 2021, regarding the specific need to have a dialogue with respect to the outstanding Community Payment. Mr. Pearson did not receive a response to this email until April 12, 2021, when Mr. Stratton indicated that the Community Payment remained outstanding. Attached hereto as Exhibit "K" is a true copy of this email discussion.
- m. Through counsel, I sent the letter attached as Exhibit "G" to my Supplemental Affidavit sworn April 12, 2021 to SFN on April 12, 2021. Attached hereto as **Exhibit** "L" is a true copy of the emails providing this letter to Mr. Stratton as well as his response.
- 5. I swear this Second Supplemental Affidavit in support of the Companies' Application and in response to the Cross-Application, and for no other or improper purpose.



Further to our calls this week and your client's discussions with Sunchild, you are aware that Westbrick is courting Sunchild for their support in the CCAA process. The pressure on Sunchild from Westbrick is significant and, at this stage,

Sunchild views Westbrick as a party with capital that can take over the asset and continue to develop it. However, as I indicated, I certainly would not count Triple Five out and there is a longstanding, positive relationship between Triple Five and Sunchild.

I ask that you share any concrete information on a commitment T5 has for capital so it can get out of CCAA protection and resolve the issues with its creditors? I am hoping to have as complete a picture as possible for Sunchild so they can make a fully informed decision. Given the pressure from Westbrick, some information in the next 24 hours would be ideal. Any documentation would be held in confidence by my office if requested.
