## NOTICE AND STATEMENT OF THE RECEIVER

(pursuant to sections 245(1) and 246(1) of the Bankruptcy and Insolvency Act)

## The receiver gives notice and declares that:

- On the 6<sup>th</sup> day of January, 2021, BDO Canada Limited ("BDO") was appointed receiver (the "Receiver") pursuant to section 101 of the Courts of Justice Act, in respect of all of the assets, undertakings and properties (collectively, the "Property") of the Carriage Ridge Owners Association (the "Carriage Ridge Resort") and the lands and premises on which the Carriage Ridge Resort operates, collectively owned by the members of the Carriage Ridge Resort (the "Lands" and together with the Property, the "Resort Assets").
- 2. Pursuant to the Order dated December 11, 2020 (the "Amended and Restated Appointment Order") of the Honourable Madame Justice Conway of the Ontario Superior Court of Justice (Commercial List) (the "Court") BDO was appointed Receiver. The Amended and Restated Appointment Order provided that the appointment of the Receiver would be effective January 6, 2021.
- 3. Prior to its appointment as Receiver, BDO was administrator (in such capacity, the "Administrator") pursuant to an Order of the Honourable Madame Justice Conway of the Court dated May 15, 2020 (the "Appointment Order") over the present and future assets, undertakings and properties of the Carriage Ridge Resort.
- 4. On the 6<sup>th</sup> day of January 2021, the Receiver took possession and control of the Resort Assets.
- 5. The book values of the Property, per the Carriage Ridge Resort's records are as follows:

- Note 1 At the date of this report, the information detailed in the table above is from draft financial reporting by the Carriage Ridge Resort and the Receiver has not yet verified these book values.
- Note 2 The Lands, furniture and fixtures are owned by individual members of the Carriage Ridge Resort. As such, the values for these assets are not reported by the Carriage Ridge Resort.
- 6. The Receiver is in the process of ascertaining the party names and amounts owing, if any, by the Carriage Ridge Resort to creditors who hold security on the Resort Assets.
