**ENDORSEMENT OF JUSTICE CONWAY:**

- [1] The Receiver scheduled this case conference to set dates for the appeals from the decisions of the Claims Officer (Mr. Duncan) on the Receiver's claims against Subject Members.
- [2] Counsel advised that the Receiver has resolved many of these appeals and that only two days of court time will now be required. However, the Receiver is still in the process of resolving more appeals.
- [3] I told counsel that it makes sense to give the Receiver a bit more time to work on these appeals before scheduling court time. I directed counsel to return to another case conference in August. At that time, I can determine how much court time will be required for the number of outstanding appeals. I assured counsel that I will schedule the court hearings in the fall of 2023.
- [4] Case conference scheduled for **August 18, 2023 at 10 a.m. for 30 minutes before me (confirmed with the CL office)**. I direct counsel for the Receiver to upload to CaseLines by noon on August 17, 2023 a one page summary of how many appeals are outstanding as at that date.
