## NOTICE AND STATEMENT OF RECEIVER

#### The Receiver gives notice and declares that:

- 1. On the 12<sup>th</sup> day of November, 2013, BDO Canada Limited was appointed Receiver pursuant to section 243(1) of the *Bankruptcy and Insolvency Act*, and section 101 of the *Courts of Justice Act R.S.O. 1990 c.43*, as amended, in respect of all of the assets, rights, property, and undertakings of Sun Pac Foods Limited (the "Company"), an insolvent person, as described in paragraph 3.
- 2. The undersigned was appointed Receiver pursuant to the Order of Justice Mesbur of the Ontario Superior Court of Justice (Commercial List) dated November 12, 2013.
