- (a) Abridging the time for service of the Notice of Motion and Motion Record, if necessary, and declaring that this motion is properly returnable on Thursday, April 23, 2015 and dispensing with further service thereof;
- (b) Approving the Second Report to Court of the Receiver dated April 17, 2015 (the "Report"), and the conduct, actions, and activities of the Receiver described therein;
- (c) Authorizing and directing the Receiver to pay the sum of \$562,778.95 plus per diem interest in the amount of \$80.64 from April 16, 2015 to the date of payment, to The Toronto-Dominion Bank ("TD") in full and final satisfaction of TD's senior secured claims against the Debtor and the Property; and
- (d) such further and other relief as counsel may advise and this Court deems just and/or equitable;

2. THE GROUNDS FOR THE MOTION ARE:

- (a) On March 31, 2015, as contemplated by the Order of Justice Newbould herein dated September 25, 2014 providing for the approval of the sale of the Property to Schlegel Villages Inc. ("SVI") or its authorized assigns (the "Approval and Vesting Order"), the Receiver completed the sale of the Property and realized proceeds of sale;
- (b) In accordance with the Approval and Vesting Order, all claims against the Debtor vest in the proceeds;
- (c) Based on the opinion of counsel to the Receiver, TD holds a valid and enforceable security interest against the Property and its proceeds;
- (d) Based on the registrations under the Land Titles Act, R.S.O 1990, c. L. 5, TD's security against the real property of the Debtor constitutes a first charge;
- (e) Based on the registrations under the Personal Property Security Act, R.S.O. 1990, c. P.
 10, TD's security against the personal property of the Debtor was registered before any

- registrations in respect of security for debts to other creditors which remain outstanding;
- (f) As of April 16, 2015, TD was owed the sum of \$562,778.95 plus per diem interest by the Debtor;
