AFFIDAVIT OF RAJBIR DHALIWAL

I, RAJBIR DHALIWAL, of the City of Winnipeg, in the Province of Manitoba,
Barrister-at-Law,

HEREBY AFFIRM AND SAY THAT:

1. I am a director of the named respondents in this Application, I have personal knowledge of the matters hereinafter deposed to by me,

except where same are stated to be based on information and belief, in which case I verily believe same to be true.

2. I have read the affidavit of Christopher Cameron, affirmed September 25, 2025 (the "Cameron Affidavit") filed by the Applicant in support of its Notice of Application herein and provide the Respondents reply hereto.
3. For the purposes of continuity and clarity, this affidavit will adopt and utilize all defined terms in the Cameron Affidavit.
4. There is no dispute as to the entering of the Master Lease, Affiliate and Master Lease as provided in the Cameron Affidavit.
5. In response to paragraph 16 of the Cameron Affidavit, is it my understanding and I verily believe that between December 2023 and January 2024, the Applicant, by way of third-party bailiffs, seized a number of the Equipment. At all material times during this period, the Equipment seizures were done without the knowledge or notification of the Respondents, and no documentation was provided by the Applicant or its agents as to which pieces of the Equipment were seized or when they were seized.

6. During the same time period, it is my understanding and belief that correspondence was exchanged between the Applicant (being Canadian Western Bank at the time) and the Respondents regarding the return of the Equipment and subsequently the Vanguard Trailers.
7. It is my further understanding and belief that part of the correspondences included requests of the Respondents to the Applicant for an extended time to return the Equipment and the Vanguard Trailers so as to allow for a maximization of retaining revenue that was attached to the used of the Equipment and Vanguard Trailers. However, it is understood that the Applicant was not agreeable and commenced efforts to seize the Equipment.
8. It is my understanding, and I verily believe that the first instance in which the Respondents became aware of any of the Equipment being seized and subsequently sold was through a message board post on Inside Transport, wherein a poster advised that the Respondent Longview Logistics Ltd. ("Longview") trailers were being sold at auction. Attached at **Exhibit "A"** to this my affidavit is a true copy of a screen shot showing the communication.

9. Further, it is my understanding and I verily believe that upon the discovery of the Inside Transport communication, the Respondents located multiple listings of the Equipment on the auction site McDougall Auctioneers on or about early February, 2024, which depicted the Equipment still having the logo of the Respondent Longview. At all material times, it was the position of the Respondents that having Longview's logo displayed on auctioned trailers inherently caused reputational harm to the Respondents. Attached at **Exhibit "B"** to this my affidavit is a true copy of the auction adds for the Vanguard Trailers showing them with the Longview logos.

10. As such, discovering that the seized Equipment did not remove any branding of the Respondent Longview, we the Respondents took immediate action to gather all of the Vanguard Trailers, being advised by the Applicant as the remaining outstanding Equipment to be seized, at our address of 13 Raynhem Drive, Centreport, Manitoba. In addition to 13 Raynhem Drive, it is my understanding and belief that the Respondents also have access to and share yard lots for storing equipment at 235 Goldenrod Drive and 302 Goldenrod Drive, Centreport, Manitoba (collectively with 13 Raynhem Drive, the "Sites"). Attached at **Exhibit "C"** to this my affidavit is a true copy of

Google Maps depicting the location of the Sites and photos of the yard located 235 Goldenrod.

11. Beginning at the end of February, 2024 through to the beginning of April 2024, all of the Vanguard Trailers were collected and stored at the 235 Goldenrod Drive for the purposes of allowing the Respondents to de-badge the Vanguard Trailers of any indicators of the Respondents, and to allow for ease of collection by the Applicant. Attached at **Exhibit "D"** to this my affidavit is a true copy of the work orders for de-badging, de-plating, and removal of the tracking devices associated with the Vanguard Trailers.

12. Concurrently with de-badging the Vanguard Trailers, it is my understanding and belief that the Respondents cancelled the Manitoba Public Insurance registration and insurance on the Vanguard Trailers. This was due to the fact that seeing as the Vanguard Trailers were to be taken by the Applicant, the Trailers would not be available for use by the Respondents and any insurance maintained would be a sunk cost. Attached at **Exhibit "E"** to this my affidavit is a true copy of the registration and insurance cancellation.

At all material times after, the Vanguard Trailers were store at 235 Goldenrod Drive.

13. It is my understanding, and I verily believe that on or about January, 2024, a third-party bailiff for the Applicant attended the Sites to seize the Vanguard Trailers, wherein an individual associated with Haulster Transport Ltd. notified the Respondents of this activity. This resulted in the contacting of the Winnipeg Police Services and/or the Royal Canadian Mounted Police, wherein, it is my understanding and belief, the third party bailiff advised the peace officers attending the Sites of its authority to seize the Vanguard Trailers.
14. Following the events at the Sites, at all materials times thereafter, the Vanguard Trailers have no longer been in the possession of the Respondents.
15. I can advise that subsequent to discovering the loss of the Vanguard Trailers, it is my understanding and belief that the Respondents contacted Haulster to inquire as to any information they had with respect to the loss of the Vanguard Trailers. I can advise and verily believe that Haulster provided no information that assisted in locating the Vanguard Trailers.

16. It is my understanding, and I verily believe that on or about June 4, 2025, the Respondents filed a police report with the RCMP pertaining to the theft/loss of the Vanguard Trailers from the Sites. Attached at **Exhibit “F”** to this my affidavit is a true copy of a photo depicting the investigator assigned to the report and the report number being #2025773942.

17. It is my understanding, and I verily believe that since April 2024, counsel for the Applicant has inquired with our lawyer, Scott Cannon of Holloway Thliveris LLP regarding the location and the return of the Vanguard Trailers, which are attached at Exhibit P of the Cameron Affidavit. At all material times, it is my understanding and belief that the Respondents have maintained the events pertaining to the collection of the Vanguard Trailers by the bailiff as aforesaid and that the Respondents wish to find same as location and sale of said Trailers would benefit the Respondents with the alleged debt owed to the Applicant in the Court of King’s Bench Action CI 24-01-48005.

18. On or about September 29, 2025, I along with the other directors of the Respondents, received an email from Jason Rathwell at BDC advising that he was notified in the week previous by counsel for the

Applicant regarding the bankruptcy application herein. Mr. Rathwell further advised stating that as a result of the pending application, the Respondents loan account with BDC would be transferred to the Special Accounts Department. Attached at **Exhibit "G"** to this my affidavit is a true copy of the email on September 29, 2025.

19. In addition to the email and soon after, I received a call from BDC advising as to the consequences of the Respondents loan account being moved to the Special Accounts Department. It is my understanding and I verily believe that with the Respondents account now being under the supervision of the Special Accounts Department, the Respondents loan with BDC, being \$5.5 million, would be under strict scrutiny and that no grace periods for reporting or payment, in particular, late payment of even a day, would result in BDC's loan being called on demand.
20. In response to paragraphs 22-24 of the Cameron Affidavit, I am not aware, nor have I been made aware by any other representatives of the Respondents, as to knowledge about the events alleged therein.

21. Attached at **Exhibit "H"** to this my affidavit is a true copy of records held by the Respondents with respect to the last pinged locations of the trackers that were placed on the Vanguard Trailers prior to their removal.

22. In response to paragraph 28 of the Cameron Affidavit, the Respondents deny and dispute the characterization by Mr. Cameron that he Respondents are actively evading and concealing the Vanguard Trailers. In further response, there is no benefit to the Respondents concealing the location of the Vanguard Trailers, as the production and eventual sale of same by the Applicant will result in the reduction of the alleged debt owed as claim in the Action, that any used of the Vanguard Trailers is impossible due to:
 - a. All transport brokers requiring insurance on a trailer before a load is authorized and agreed to for shipment;
 - b. That the use of the trailers would result in having to use weigh stations that will check registrations and VIN's of the trailers;
 - c. That the VIN's are readily visible on the Vanguard Trailers, and are checked during any cross-dock, movement over border,

which would trigger a reporting of their location, rendering any illicit use of same to be fruitless;

23. In response to the Cameron Affidavit and the Application as a whole, I am not accurately aware of all events as described by the Mr. Cameron in his affidavit with respect to actions taken by the Applicant to retrieve the Vanguard Trailers. However, at all material times, the actions of the Respondents have not included any attempts to delay or refuse to produce the Vanguard Trailers, and that the Exhibits in Mr. Cameron's affidavit illustrate continued communication and efforts by the Respondents and its agents to work with the Applicant (and CWB as it was then) with respect to the Vanguard Trailers.
24. In further response to the Cameron Affidavit and the Application as a whole, I can advise and verily believe that at all material times, an order for a receivership will be detrimental to the business of the Respondents, that it will become public knowledge above and beyond what already exists, and that customers and brokers will be hesitant to do business with the Respondents as a result.
25. It is my understanding and belief that the Applicant can obtain any and all relief it seeks under the Application without a formal

receivership order, that the Respondents are willing act in accordance with the Applicant to achieve the joint goal of locating and selling the Vanguard Trailers

26. I make this affidavit *bona fide*.

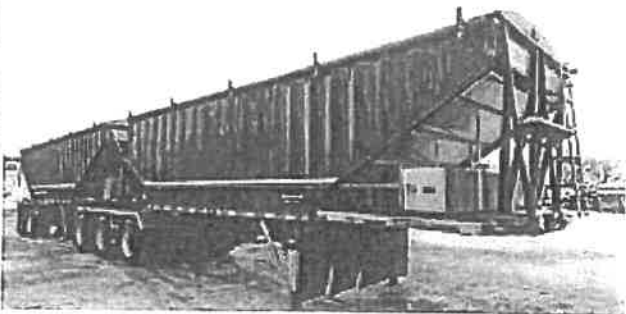

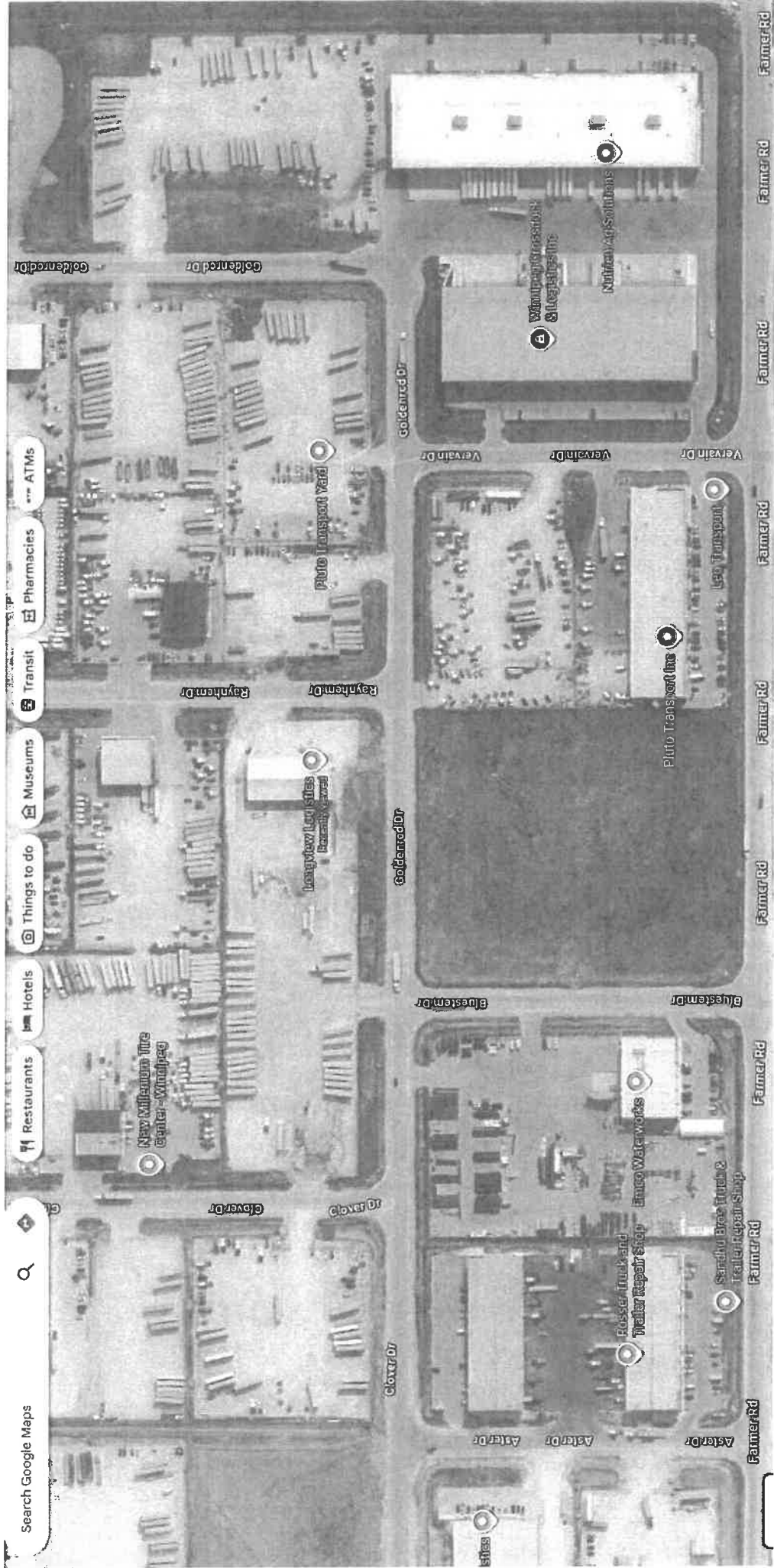

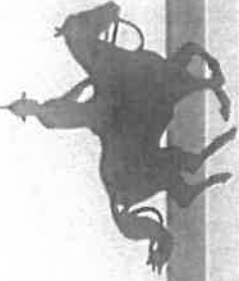
